HOUSE BILL NO. 605

1 AN ACT TO AMEND SECTION 37-19-7, MISSISSIPPI CODE OF 1972, TO 2 REQUIRE THE STATE DEPARTMENT OF EDUCATION TO PAY A SALARY 3 SUPPLEMENT TO PERSONS EMPLOYED AS A LICENSED TEACHER IN A CRITICAL 4 SHORTAGE SUBJECT AREA BY A SCHOOL DISTRICT ASSIGNED AN ACCOUNTABILITY RATING OF "D" OR "F"; AND FOR RELATED PURPOSES. 5 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. Section 37-19-7, Mississippi Code of 1972, is amended as follows: 8 9 37-19-7. (1) The allowance in the Mississippi Adequate 10 Education Program for teachers' salaries in each public school 11 district shall be determined and paid in accordance with the scale 12 for teachers' salaries as provided in this subsection. For teachers holding the following types of licenses or the equivalent 13 14 as determined by the State Board of Education, and the following 15 number of years of teaching experience, the scale shall be as 16 follows: 17 2022-2023 AND SUBSEQUENT SCHOOL YEARS MINIMUM SALARY SCHEDULE 18 Exp. It is the intent of the Legislature that any state funds made available for salaries of licensed personnel in excess of the funds paid for such salaries for the 1986-1987 school year shall be paid to licensed personnel pursuant to a personnel appraisal and compensation system implemented by the State Board of Education. The State Board of Education shall have the authority to adopt and amend rules and regulations as are necessary to establish, administer and maintain the system.

All teachers employed on a full-time basis shall be paid a minimum salary in accordance with the above scale. However, no school district shall receive any funds under this section for any school year during which the local supplement paid to any individual teacher shall have been reduced to a sum less than that paid to that individual teacher for performing the same duties

- 71 year. The amount actually spent for the purposes of group health
- 72 and/or life insurance shall be considered as a part of the
- 73 aggregate amount of local supplement but shall not be considered a
- 74 part of the amount of individual local supplement.
- 75 The level of professional training of each teacher to be used
- 76 in establishing the salary allotment for the teachers for each
- 77 year shall be determined by the type of valid teacher's license
- 78 issued to those teachers on or before October 1 of the current
- 79 school year. However, school districts are authorized, in their
- 80 discretion, to negotiate the salary levels applicable to licensed
- 81 employees who are receiving retirement benefits from the
- 82 retirement system of another state, and the annual experience
- 83 increment provided * * * in * * * this subsection shall not be
- 84 applicable to any such retired * * * licensed employee.
- 85 (2) (a) The following employees shall receive an annual
- 86 salary supplement in the amount of Six Thousand Dollars
- 87 (\$6,000.00), plus fringe benefits, in addition to any other
- 88 compensation to which the employee may be entitled:
- 89 (i) Any licensed teacher who has met the
- 90 requirements and acquired a Master Teacher certificate from the
- 91 National Board for Professional Teaching Standards and who is
- 92 employed by a local school board or the State Board of Education
- 93 as a teacher and not as an administrator. Such teacher shall
- 94 submit documentation to the State Department of Education that the

- 95 certificate was received prior to October 15 in order to be
- 96 eligible for the full salary supplement in the current school
- 97 year, or the teacher shall submit such documentation to the State
- 98 Department of Education prior to February 15 in order to be
- 99 eligible for a prorated salary supplement beginning with the
- 100 second term of the school year.
- 101 (ii) A licensed nurse who has met the requirements
- 102 and acquired a certificate from the National Board for
- 103 Certification of School Nurses, Inc., and who is employed by a
- 104 local school board or the State Board of Education as a school
- 105 nurse and not as an administrator. The licensed school nurse
- 106 shall submit documentation to the State Department of Education
- 107 that the certificate was received before October 15 in order to be
- 108 eligible for the full salary supplement in the current school
- 109 year, or the licensed school nurse shall submit the documentation
- 110 to the State Department of Education before February 15 in order
- 111 to be eligible for a prorated salary supplement beginning with the
- 112 second term of the school year.
- 113 (iii) Any licensed school counselor who has met
- 114 the requirements and acquired a National Certified School
- 115 Counselor (NCSC) endorsement from the National Board of Certified
- 116 Counselors and who is employed by a local school board or the
- 117 State Board of Education as a counselor and not as an
- 118 administrator. Such licensed school counselor shall submit
- 119 documentation to the State Department of Education that the

120	endorsement was received prior to October 15 in order to be
121	eligible for the full salary supplement in the current school
122	year, or the licensed school counselor shall submit such
123	documentation to the State Department of Education prior to
124	February 15 in order to be eligible for a prorated salary
125	supplement beginning with the second term of the school year.
126	However, any school counselor who started the National Board for
127	Professional Teaching Standards process for school counselors
128	between June 1, 2003, and June 30, 2004, and completes the
129	requirements and acquires the Master Teacher certificate shall be
130	entitled to the master teacher supplement, and those counselors
131	who complete the process shall be entitled to a one-time
132	reimbursement for the actual cost of the process as outlined in
133	paragraph (b) of this subsection.
134	(iv) Any licensed speech-language pathologist and
135	audiologist who has met the requirements and acquired a
136	Certificate of Clinical Competence from the American
137	Speech-Language-Hearing Association and any certified academic
138	language therapist (CALT) who has met the certification
139	requirements of the Academic Language Therapy Association and who
140	is employed by a local school board. The licensed speech-language
141	pathologist and audiologist and certified academic language
142	therapist shall submit documentation to the State Department of
143	Education that the certificate or endorsement was received before
144	October 15 in order to be eligible for the full salary supplement

145	in the current school year, or the licensed speech-language
146	pathologist and audiologist and certified academic language
147	therapist shall submit the documentation to the State Department
148	of Education before February 15 in order to be eligible for a
149	prorated salary supplement beginning with the second term of the
150	school year.

- (v) Any licensed athletic trainer who has met the requirements and acquired Board Certification for the Athletic Trainer from the Board of Certification, Inc., and who is employed by a local school board or the State Board of Education as an athletic trainer and not as an administrator. The licensed athletic trainer shall submit documentation to the State Department of Education that the certificate was received before October 15 in order to be eligible for the full salary supplement in the current school year, or the licensed athletic trainer shall submit the documentation to the State Department of Education before February 15 in order to be eligible for a prorated salary supplement beginning with the second term of the school year.
- (b) An employee shall be reimbursed for the actual cost of completing each component of acquiring the certificate or endorsement, excluding any costs incurred for postgraduate courses, not to exceed Five Hundred Dollars (\$500.00) for each component, not to exceed four (4) components, for a teacher, school counselor or speech-language pathologist and audiologist, regardless of whether or not the process resulted in the award of

170 the certificate or endorsement. A local school district or any 171 private individual or entity may pay the cost of completing the 172 process of acquiring the certificate or endorsement for any employee of the school district described under paragraph (a), and 173 174 the State Department of Education shall reimburse the school 175 district for such cost, regardless of whether or not the process 176 resulted in the award of the certificate or endorsement. 177 private individual or entity has paid the cost of completing the 178 process of acquiring the certificate or endorsement for an employee, the local school district may agree to directly 179 180 reimburse the individual or entity for such cost on behalf of the 181 employee.

(c) All salary supplements, fringe benefits and process reimbursement authorized under this subsection shall be paid directly by the State Department of Education to the local school district and shall be in addition to its adequate education program allotments and not a part thereof in accordance with regulations promulgated by the State Board of Education. Local school districts shall not reduce the local supplement paid to any employee receiving such salary supplement, and the employee shall receive any local supplement to which employees with similar training and experience otherwise are entitled. However, an educational employee shall receive the salary supplement in the amount of Six Thousand Dollars (\$6,000.00) for only one (1) of the qualifying certifications authorized under paragraph (a) of this

- 211 purpose, any licensed teacher who has met the requirements and
- 212 acquired a Master Teacher Certificate from the National Board for
- 213 Professional Teaching Standards and who is employed in a public
- 214 school district located in one (1) of the following counties:
- 215 Claiborne, Adams, Jefferson, Wilkinson, Amite, Bolivar, Coahoma,
- 216 Leflore, Quitman, Sharkey, Issaquena, Sunflower, Washington,
- 217 Holmes, Yazoo and Tallahatchie. The salary supplement awarded
- 218 under the provisions of this subsection (3)(a) shall be in

221	Teachers who meet the qualifications for a salary supplement
222	under this subsection (3) who are assigned for less than one (1)
223	full year or less than full time for the school year shall receive
224	the salary supplement in a prorated manner, with the portion of
225	the teacher's assignment to the critical geographic area to be
226	determined as of June 15th of the school year.

(b) Beginning in the 2024-2025 school year, a licensed teacher employed in a teaching position in a subject area in which there exists a critical shortage of teachers, as determined by the State Department of Education, by a school district that has been assigned an accountability rating of "D" or "F" is eligible for an annual salary supplement in an amount determined by the local school district, not to exceed Fifteen Thousand Dollars (\$15,000.00). The amount of a salary supplement under this subsection (3)(b) for a qualified teacher must be established by the employer school district, with consideration given to the teacher's number of years experience in the critical needs subject area, educational attainment, and professional certifications, including a Master Teacher certificate from the National Board for Professional Teaching Standards. The State Department of Education shall pay directly to the local school district all

salary supplements awarded under this subsection (3)(b), which is

269 access to the monies set aside in this section, the MPBP program 270 shall be designed to calculate each school's performance as 271 determined by the school's increase in scores from the prior 272 school year. The MPBP program shall be based on a standardized 273 scores rating where all levels of schools can be judged in a 274 statistically fair and reasonable way upon implementation. At the 275 end of each year, after all student achievement scores have been 276 standardized, the State Department of Education shall implement 277 the MPBP plan.

278 (iii) To ensure all teachers cooperate in the 279 spirit of teamwork, individual schools shall submit a plan to the 280 local school district to be approved before the beginning of each 281 school year beginning July 1, 2008. The plan shall include, but 282 not be limited to, how all teachers, regardless of subject area, 283 and administrators will be responsible for improving student 284 achievement for their individual school.

- The State Board of Education shall develop the (b) processes and procedures for designating schools eligible to participate in the MPBP. State assessment results, growth in student achievement at individual schools and other measures deemed appropriate in designating successful student achievement shall be used in establishing MPBP criteria.
- 291 If funds are available for that purpose, each (5) (a) 292 school in Mississippi shall have mentor teachers, as defined by 293 Sections 37-9-201 through 37-9-213, who shall receive additional

294	base compensation provided for by the State Legislature in the
295	amount of One Thousand Dollars (\$1,000.00) per each beginning
296	teacher that is being mentored. The additional state compensation
297	shall be limited to those mentor teachers that provide mentoring
298	services to beginning teachers. For the purposes of such funding,
299	a beginning teacher shall be defined as any teacher in any school
300	in Mississippi that has less than one (1) year of classroom
301	experience teaching in a public school. For the purposes of such
302	funding, no full-time academic teacher shall mentor more than two
303	(2) beginning teachers.

- 304 (b) To be eligible for this state funding, the 305 individual school must have a classroom management program 306 approved by the local school board.
- 307 (6) Effective with the 2014-2015 school year, the school 308 districts participating in the Pilot Performance-Based 309 Compensation System pursuant to Section 37-19-9 may award 310 additional teacher and administrator pay based thereon.
- 311 **SECTION 2.** This act shall take effect and be in force from 312 and after July 1, 2024.
