HOUSE BILL NO. 696

1 AN ACT TO AMEND SECTION 3-3-7, MISSISSIPPI CODE OF 1972, TO 2 DESIGNATE JUNE 12, WOMEN'S VETERANS' DAY, AS A LEGAL HOLIDAY IN 3 THE STATE OF MISSISSIPPI; AND FOR RELATED PURPOSES. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: WHEREAS, women have honorably and courageously served in all 5 of America's wars and conflicts since the American Revolution, but 6 7 their service went unrecognized; and WHEREAS, the first Women's Veterans' Day was held June 12, 8

- 9 2018, marking the 70th anniversary of the Women's Armed Services
- Integration Act, which was signed into law by President Harry S. 10
- 11 Truman on June 12, 1948, enabling women to serve as permanent,
- regular members of the Army, Marine Corps, Navy and the recently 12
- 13 formed Air Force; and
- 14 WHEREAS, during World War II, approximately 400,000 women
- served in support positions with the military, and nearly 500 were 15
- 16 killed in enemy fire; and
- WHEREAS, though women were officially recognized as military 17
- 18 members or veterans in 1948, they had been serving in the American

- 19 military since before the United States became a nation, often
- 20 serving in the civilian fields in positions such as nursing and
- 21 cooking; and
- 22 WHEREAS, women now make up about 20% of new recruits, 16% of
- 23 personnel serving on active duty, and 19% of the National Guard
- 24 and Reserve Forces; and
- 25 WHEREAS, the Department of Veterans Affairs and the
- 26 Mississippi State Veterans Affairs Board remain committed to
- 27 providing over 200,000 Mississippi women veterans with exceptional
- 28 healthcare and services; and
- 29 WHEREAS, as members of the Legislature, we salute and
- 30 remember the women who courageously served our state and nation,
- 31 and we honor our female veterans and their families for their
- 32 outstanding service, sacrifice and remarkable dedication to our
- 33 nation; NOW, THEREFORE,
- 34 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 35 **SECTION 1.** Section 3-3-7, Mississippi Code of 1972, is
- 36 amended as follows:
- 37 3-3-7. (1) Except as otherwise provided in subsection (2)
- 38 of this section, the following are declared to be legal
- 39 holidays * * *: the first day of January (New Year's Day); the
- 40 third Monday of January (Robert E. Lee's birthday and Dr. Martin
- 41 Luther King, Jr.'s birthday); the third Monday of February
- 42 (Washington's birthday); the last Monday of April (Confederate
- 43 Memorial Day); the last Monday of May (National Memorial Day and

- 44 Jefferson Davis' birthday); the twelfth day of June (Women's
- 45 Veterans' Day); the fourth day of July (Independence Day); the
- 46 first Monday of September (Labor Day); the eleventh day of
- 47 November (Armistice or Veterans' Day); the day fixed by
- 48 proclamation by the Governor of Mississippi as a day of
- 49 Thanksgiving, which shall be fixed to correspond to the date
- 50 proclaimed by the President of the United States (Thanksgiving
- 51 Day); and the twenty-fifth day of December (Christmas Day). In
- 52 the event any holiday hereinbefore declared legal shall fall on
- 53 Sunday, then the next following day shall be a legal holiday.
- 54 (2) In lieu of any one (1) legal holiday provided for in
- 55 subsection (1) of this section, with the exception of the third
- 56 Monday in January (Robert E. Lee's and Martin Luther King, Jr.'s
- 57 birthday) and the eleventh day of November (Armistice or Veterans'
- 58 Day), the governing authorities of any municipality or county may
- 59 declare, by order spread upon its minutes, Mardi Gras Day or any
- one (1) other day during the year, to be a legal holiday.
- 61 (3) August 16 is declared to be Elvis Aaron Presley Day in
- 62 recognition and appreciation of Elvis Aaron Presley's many
- 63 contributions, international recognition and the rich legacy left
- 64 to us by Elvis Aaron Presley. This day shall be a day of
- 65 recognition and observation and shall not be recognized as a legal
- 66 holiday.
- 67 (4) May 8 is declared to be Hernando de Soto Day in
- 68 recognition, observation and commemoration of Hernando de Soto,

- 69 who led the first and most imposing expedition ever made by
- 70 Europeans into the wilds of North America and the State of
- 71 Mississippi, and in further recognition of the Spanish explorer's
- 72 187-day journey from the Tombigbee River basin on our state's
- 73 eastern boundary, westward to the place of discovery of the
- 74 Mississippi River on May 8, 1541. This day shall be a day of
- 75 commemoration, recognition and observation of Hernando de Soto and
- 76 European exploration and shall not be recognized as a legal
- 77 holiday.
- 78 (5) Armistice Day (Veterans' Day) shall be observed by
- 79 appropriate exercises in all the public schools in the State of
- 80 Mississippi. The superintendent of schools of each public school
- 81 district is authorized to provide for the appearance of uniformed
- 82 military personnel, uniformed veterans or the families of fallen
- 83 military personnel/veterans at such public school exercises in
- 84 honor of Armistice (Veterans') Day. The superintendent of schools
- 85 is also authorized to permit the school band and its director(s)
- 86 at any public school in the district to perform at Armistice
- 87 (Veterans') Day exercises in the school district upon the request
- 88 of public officials or veterans associations without loss of any
- 89 program credit by participating students and without loss of leave
- 90 by participating school personnel.
- 91 **SECTION 2.** This act shall take effect and be in force from
- 92 and after July 1, 2024.
