COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 907

1 AN ACT TO CREATE THE MISSISSIPPI CHILDCARE TEACHERS SHORTAGE 2 STUDY COMMITTEE; TO PROVIDE THAT THE COMMITTEE IS TO STUDY THE 3 MISSISSIPPI CHILDCARE WORKER SHORTAGE AND HOW TO INCREASE THE SUPPLY OF AFFORDABLE CHILDCARE SEATS WHILE ALSO RECOGNIZING 5 EDUCATORS FOR THEIR ONGOING EFFORTS TO IMPROVE MISSISSIPPI'S EARLY EDUCATION AND CARE SYSTEM; TO PROVIDE THE MEMBERS OF THE 6 7 COMMITTEE; TO PROVIDE WHAT THE STUDY COMMITTEE SHALL REVIEW; TO REQUIRE THE STUDY COMMITTEE TO REPORT TO CERTAIN OFFICIALS BY 8 9 DECEMBER 1, 2024; AND FOR RELATED PURPOSES. 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 11 SECTION 1. (1) There is created the Mississippi Childcare

- 12 Teachers Shortage Study Committee. The purpose of the committee
- 13 is to study the Mississippi childcare worker shortage and how to
- 14 increase the supply of affordable childcare seats while also
- 15 recognizing educators for their ongoing efforts to improve
- Mississippi's early education and care system. 16
- 17 The Mississippi Childcare Teachers Shortage Study
- 18 Committee shall be comprised of the following members:
- 19 (a) One (1) member of the Mississippi Senate, to be
- 20 appointed by the Lieutenant Governor;

- 22 appointed by the Speaker of the House of Representatives;
- 23 (c) The Executive Director of the Mississippi
- 24 Department of Human Services, or a designee, as an ex officio
- 25 member;
- 26 (d) The Executive Director of the Mississippi
- 27 Department of Employment Services, or a designee, as an ex officio
- 28 member;
- 29 (e) One (1) representative of the childcare provider
- 30 community, to be appointed by the Executive Director of the
- 31 Mississippi Office of Workforce Development;
- 32 (f) One (1) representative of the economic development
- 33 community, to be appointed by the Executive Director of the
- 34 Mississippi Office of Workforce Development; and
- 35 (g) One (1) representative of business and industry, to
- 36 be appointed by the Executive Director of the Mississippi Office
- 37 of Workforce Development.
- 38 (3) Appointments shall be made within thirty (30) days after
- 39 the sine die adjournment of the 2024 Regular Session. At the
- 40 first meeting, the study committee shall elect a chair and a vice
- 41 chair. The study committee shall meet and organize fifteen (15)
- 42 days after all appointments have been made. The vice chair shall
- 43 also serve as secretary and shall be responsible for keeping all
- 44 records of the study committee. A majority of the members of the
- 45 study committee shall constitute a quorum. In the selection of

- 46 its officers and the adoption of rules, resolutions and reports,
- 47 an affirmative vote of a majority of the study committee shall be
- 48 required. All members shall be notified in writing of all
- 49 meetings, such notices to be mailed at least fifteen (15) days
- 50 before the date on which a meeting is to be held. Members of the
- 51 study committee shall not be compensated or reimbursed for travel
- 52 expenses.
- 53 (4) The study committee shall study and make a report on the
- 54 following:
- 55 (a) Whether a wage incentive program for childcare
- 56 teachers would yield positive results in Mississippi;
- 57 (b) The wage incentive programs offered to childcare
- 58 teachers in other states;
- 59 (c) How to address the childcare teacher shortage in
- 60 Mississippi;
- 61 (d) How other states have addressed their childcare
- 62 teacher shortages; and
- 63 (e) Other childcare related issues that the committee
- 64 deems necessary to review and study.
- 65 (5) The study committee shall submit its report to the
- 66 Governor, Lieutenant Governor, Speaker of the House of
- 67 Representatives, Chairmen of the House and Senate Appropriations
- 68 Committees, the Chairman of the House Workforce Development
- 69 Committee and the Chairman of the Senate Economic and Workforce

- 70 Development Committee by December 1, 2024. After such report is
- 71 submitted, the study committee shall be dissolved.
- 72 **SECTION 2.** This act shall take effect and be in force from
- 73 and after its passage.
