## COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 1210

AN ACT TO ESTABLISH THE "DR. ELTON MAC HUDDLESTON RURAL VETERINARIANS SCHOLARSHIP PROGRAM AT MISSISSIPPI STATE UNIVERSITY" FOR THE PURPOSE OF PROVIDING SCHOLARSHIPS TO QUALIFYING STUDENTS PURSUING A DEGREE IN VETERINARY MEDICINE, WHO WILL THEN COMMIT TO 5 THE PRACTICE OF VETERINARY MEDICINE IN RURAL AREAS OF THE STATE; TO PROVIDE THAT THE DEAN OF THE MISSISSIPPI STATE UNIVERSITY 7 COLLEGE OF VETERINARY MEDICINE SHALL ADMINISTER THE SCHOLARSHIP PROGRAM; TO CAP THE NUMBER OF SCHOLARSHIPS AWARDED ANNUALLY; TO 8 9 LIMIT TO FOUR YEARS DURATION FOR WHICH A STUDENT MAY RECEIVE 10 SCHOLARSHIP FUNDS; TO DEFINE TERMINOLOGY USED IN THE ACT; TO 11 AUTHORIZE THE DEAN OF THE COLLEGE OF VETERINARY MEDICINE TO 12 PROMULGATE RULES AND REGULATIONS FOR THE ADMINISTRATION OF THE PROGRAM WITH THE ADVICE AND CONSENT OF THE PRESIDENT OF MISSISSIPPI STATE UNIVERSITY AND THE BOARD OF TRUSTEES OF STATE 14 15 INSTITUTIONS OF HIGHER LEARNING; TO PRESCRIBE THE MINIMUM CRITERIA 16 FOR ELIGIBILITY FOR RECEIPT OF SCHOLARSHIP, CONTINUED MAINTENANCE 17 OF THE SCHOLARSHIP AND POST PROGRAM COMPLETION OBLIGATIONS AND 18 PENALTIES FOR FAILURE TO PERFORM THE CONTRACTUAL OBLIGATION OF THE SCHOLARSHIP AGREEMENT; TO AUTHORIZE THE MISSISSIPPI STATE 19 20 UNIVERSITY COLLEGE OF VETERINARY MEDICINE IS AUTHORIZED TO ACCEPT 21 GIFTS, DONATIONS, BEQUESTS, GRANTS AND ANY OTHER MONIES FROM ANY 22 SOURCE WHATSOEVER TO BE USED FOR THE PURPOSES OF ADMINISTERING THE 23 PROGRAM; TO REQUIRE THE DEAN TO SUBMIT AN ANNUAL REPORT TO THE 24 LEGISLATURE WITH INFORMATION ABOUT WHO RECEIVED SCHOLARSHIPS UNDER 25 THE PROGRAM AND HOW MUCH EACH PERSON RECEIVED, AND THE AMOUNT OF 26 ANY GIFTS, DONATIONS AND OTHER FUNDS RECEIVED AND HOW THOSE FUNDS 27 WERE USED FOR THE PURPOSE OF THE PROGRAM; AND FOR RELATED 28 PURPOSES.

- 29 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 30 SECTION 1. There is established, at Mississippi State
- 31 University, the "Dr. Elton Mac Huddleston Rural Veterinarians

- 33 qualified students with scholarships to assist such students in
- 34 pursuing degrees through matriculation in veterinary medicine.
- 35 The scholarship program shall:
- 36 (a) Be developed and implemented in order to provide
- 37 encouragement, opportunities and incentives for persons pursuing a
- 38 veterinary medicine degree at Mississippi State University to:
- 39 (i) Provide veterinary services in rural
- 40 Mississippi communities; and
- 41 (ii) Receive specialized training to meet the
- 42 needs of rural Mississippians and livestock producers in rural
- 43 Mississippi communities;
- 44 (b) Be administered by the Dean of the Mississippi
- 45 State University College of Veterinary Medicine; and
- 46 (c) Annually award scholarships to an average of two

- 49 **SECTION 2.** As used in this act, the following terms shall
- 50 have the meanings ascribed in this section unless context of use
- 51 clearly requires otherwise:
- 52 (a) "Veterinary student" means a student enrolled in
- 53 the Mississippi State University College of Veterinary Medicine.
- 54 (b) "Dean" means the Dean of the Mississippi State
- 55 University College of Veterinary Medicine.

- (d) "Food supply animal veterinarian" means a
  veterinarian who is engaged in general or food supply animal
  practice as his or her primary focus of practice and who has
  thirty percent (30%) of his or her practice devoted to food supply
  animal veterinary medicine.
- (e) "Large animal veterinarian" means a veterinarian
  whose practice is focused primarily on the health and safety of
  farm animals such as cattle, sheep, goats, pigs and horses, who
  must spend sixty percent (60%) of their time providing care for
  large animals.
- (f) "Program" means the Dr. Elton Mac Huddleston Rural
  Veterinarian Scholarship Program administered by the Mississippi
  State University College of Veterinary Medicine.
- 71 (g) "Rural community" means an area of the state with a 72 population density less than five hundred (500) people per square 73 mile as defined by the United States Department of Agriculture.
- (h) "Rural mixed animal veterinarian" means a
  veterinarian who practices in a rural community with provision of
  care to both small animals, i.e., dogs or cats, and large animals,
  i.e., cattle, sheep, goats, pigs or horses, within which the
  veterinarian must spend a minimum of thirty percent (30%) of his
  or her time providing care to large animals.

- 90 (c) Annually establish a selection committee, composed

- 93 animal veterinarians, which shall conduct a process, independent
- 94 from the university's Admissions Committee, to review
- 95 applications, conduct virtual or in-person interviews and select

- 98 the President of Mississippi State University of the Board of
- 99 Trustees of State Institutions of Higher Learning, to support the
- 100 activities of the program and periodically review, and if

- 106 (f) Develop and participate in programs that provide 107 initial practice support in collaboration with other interested 108 professional organizations;
- 109 Give preference for approving communities for 110 purposes of Section 4(2)(d) to communities located in areas 111 designated by the American Veterinary Medical Association or the 112 United States Department of Agriculture as veterinary shortage 113 areas.
- 114 SECTION 4. (1)(a) Subject to the availability of funds, 115 the program may annually enter into agreements with up to an average of two (2) veterinary students as determined by the 116 criteria established for the administration of the Dr. Elton Mac 117 118 Huddleston Rural Veterinarians Scholarship Program.
- 119 Each student entering into a program agreement (b) under this section shall receive annual assistance in an amount 120 121 not to exceed the in-state tuition rate assessed for attending the 122 Mississippi State University College of Veterinary Medicine for a 123 period not to exceed four (4) years for tuition and fees incurred 124 by the student in pursuit of his or her veterinary medicine 125 degree. Upon completion of all commitments under the provisions 126 of the agreement and the provisions of this section, the financial

127	obligations	pursuant	to	this	section	shall	be	deemed	satisfied	and

- 129 (2) To be eligible for program scholarship funds, recipients
- 130 shall:
- 131 (a) Be a student of the Mississippi State University
- 132 College of Veterinary Medicine;
- (b) Agree to become licensed in the practice of
- 134 veterinary medicine in the State of Mississippi upon graduation;
- 135 (c) Complete all requirements in public health,
- 136 livestock biosecurity, foreign animal disease diagnosis,
- 137 regulatory veterinary medicine and zoonotic disease, and an
- 138 externship and mentoring requirement with a licensed, accredited
- 139 veterinarian in a rural area, as required by the veterinary
- 140 medical school;
- 141 (d) Enter into a contract with the program to provide
- 142 full-time veterinary medicine services as a food supply animal
- 143 veterinarian or as a rural mixed animal veterinarian for a minimum
- 144 of four (4) years in one or more communities approved by the
- 145 program; and
- 146 (e) Commence the full-time practice of veterinary
- 147 medicine in a rural community within ninety (90) days after
- 148 completion of the degree program or, if the scholarship recipient
- 149 enters a post-degree training program, such as graduate school,
- 150 internship or residency program, within ninety (90) days after
- 151 completion of the post-degree training program; and

152	(f) Be accredited by the United States Department of
153	Agriculture, Animal and Plant Health Inspection Service,
154	Veterinary Services to provide services relating to food supply
155	animals within six (6) months of graduation or passage of
156	veterinary licensure examination.

- (3) Priority shall be given to Mississippi residents. If the number of Mississippi residents applying for scholarship funds is less than the number of slots available, nonresident students may be considered. Nonresident students shall only receive scholarship funds sufficient to pay for in-state tuition rates, and they must meet the same obligations as specified in subsection (2) of this section for students who are residents of the State of Mississippi.
- 165 Recipients of the scholarship must remain in good 166 academic standing while in receipt of this scholarship, as 167 specified in the rules and regulations promulgated by the Dean of 168 the Mississippi State University College of Veterinary Medicine with the advice and consent of the President of Mississippi State 169 170 University of the Board of Trustees of State Institutions of 171 If a student is dismissed or withdraws from the Higher Learning. 172 Mississippi State University College of Veterinary Medicine, the 173 dean shall assess the circumstances of the student's dismissal or withdrawal and make a formal recommendation regarding whether the 174 175 student shall be liable for the repayment of all or a portion of the financial assistance provided to the student through the 176

- program, along with other penalties that may be prescribed in accordance with the policies adopted by the dean as prescribed in Section 6 of this act.
- (5) The dean may adopt additional provisions, requirements or conditions for participating in the program as are practicable and appropriate to accomplish the provisions of the program or which may be required for the implementation or administration of the program, and which are not inconsistent with the provisions of this section.
- SECTION 5. (1) The Mississippi State University College of
  Veterinary Medicine is authorized to accept gifts, donations,
  bequests, trusts, grants, endowments, transfers of money or
  securities, repayments and any other monies from any source
  whatsoever to be used for the purposes of administering the Dr.
  Elton Mac Huddleston Rural Veterinarians Scholarship Program.
  - (2) The dean shall prepare and submit an annual report to the Legislature not later than December 1 of each year, which shall include, but not be limited to, information about who received scholarships under the program and how much each person received, and the amount of any funds received under subsection (1) of this section and how those funds were used for the purpose of the program.

- 203 **SECTION 6.** (1) A veterinarian shall be released from the 204 program contract without penalty if:
- 205 (a) The veterinarian has completed the service 206 requirements of the contract;
- 207 (b) The veterinarian is unable to complete the service 208 requirements of the contract because of a permanent physical 209 disability;
- 210 (c) The veterinarian demonstrates extreme hardship or 211 shows other good cause justifying the release; or
- 212 (d) The veterinarian dies.
- 213 (2) An obligation to engage in the practice of veterinary 214 medicine in accordance with the provisions of Section 4 shall be 215 postponed during:
- 216 (a) Any period of temporary medical disability during
  217 which the person obligated is unable to practice veterinary
  218 medicine due to the disability; and
- (b) Any other period of postponement agreed to or

  determined in accordance with criteria agreed to in the practice

  agreement.
- 222 (3) A veterinarian shall be released from further
  223 performance of veterinary services under the program contract if
  224 he or she is unable to perform his or her contractual obligations
  225 to provide veterinary services due to the suspension or revocation

226 of his or her federal accreditation or denial, refusal of renewal, 227 limitation, suspension, revocation, or other disciplinary measure 228 taken against his or her license to practice in the State of 229 Mississippi pursuant to the Mississippi Veterinary Practice Act, 230 Chapter 39, Title 73, Mississippi Code of 1972, particularly, Sections 73-39-75 and 73-39-77. If a veterinarian is released 231 232 from his or her contract pursuant to this subsection, the program 233 may recover a portion of or all of the payments made to such 234 veterinarian under Section 4 of this act. The dean may use appropriate remedies available to enforce this subsection.

- Upon the failure of a person to satisfy the obligation to engage in the full-time practice of veterinary medicine in a rural community in accordance with the provisions of this section with no just cause as outlined in subsection (1), that person shall, within ninety (90) days of the failure, be liable for the repayment of all financial assistance provided to such person through the program prescribed in accordance with the policies adopted by the dean, less a prorated amount based on any periods of veterinary medicine practice meeting the requirements of this section, plus interest at the prime rate of two percent (2%) from the date the assistance accrued. The interest on any unpaid obligation for violations specified in this subsection shall be compounded annually.
- 249 SECTION 7. This act shall take effect and be in force from 250 and after July 1, 2024.
