7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
8	SECTION 1. (1) The Department of Finance and
9	Administration, acting on behalf of the Mississippi Department of
10	Public Safety, hereinafter DPS, shall transfer and convey the
11	facility currently used by and for the benefit of the Highway
12	Safety Patrol as its headquarters facility in Jackson,
13	Mississippi, to the Board of Trustees of State Institutions of
14	Higher Learning, for the use and benefit of the University of
15	Mississippi Medical Center upon such terms and conditions as is
16	agreed upon by DPS and the board, in consultation with the
17	Department of Finance and Administration. The property being more
