HOUSE BILL NO. 1274

1 AN ACT TO AUTHORIZE THE OFFICE OF WORKFORCE DEVELOPMENT TO 2 PARTNER WITH THE MISSISSIPPI ALLIANCE OF NONPROFITS AND 3 PHILANTHROPY TO CREATE A PROTOTYPE SYSTEM THAT WILL IDENTIFY, 4 DOCUMENT, NETWORK, ASSESS NEEDS AND CREATE A PLAN FOR INCREASING 5 ACCOUNTABILITY, TRANSPARENCY, OPERATIONAL CAPACITY AND INFORMATION 6 SHARING FOR NONPROFIT ORGANIZATIONS IN MISSISSIPPI THAT ARE 7 AWARDED GRANTS AND CONTRACTS THAT USE FEDERAL OR STATE RESOURCES 8 THAT ARE RELATED TO WORKFORCE DEVELOPMENT AND EMPLOYMENT SERVICES; 9 TO REQUIRE THE OFFICE AND THE ALLIANCE TO EXECUTE A MEMORANDUM OF UNDERSTANDING BETWEEN THEM THAT DETAILS THE SCOPE OF WORK, 10 11 ANTICIPATED OUTCOMES AND THE TIMELINE FOR DEVELOPING THE PROTOTYPE 12 SYSTEM; TO REQUIRE ALL AGENCIES, INSTITUTIONS AND DEPARTMENTS THAT 13 SUB-GRANT OR CONTRACT WITH NONPROFITS FOR WORKFORCE OR EMPLOYMENT SERVICES, AND ANY NONPROFIT THAT RECEIVES SUCH SUB-GRANT OR 14 15 CONTRACT, TO PROVIDE ANY INFORMATION THAT MAY BE REQUESTED FROM 16 THE OFFICE OR THE ALLIANCE; AND FOR RELATED PURPOSES. 17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 18 **SECTION 1.** (1) Subject to appropriation, the Office of 19 Workforce Development, hereinafter the "office", shall partner 20 with the Mississippi Alliance of Nonprofits and Philanthropy, hereinafter the "alliance", to create a prototype system that will 21 22 identify, document, network, assess needs and create a plan for 23 increasing accountability, transparency, operational capacity and 24 information sharing for nonprofit organizations in Mississippi 25 that are awarded grants and contracts that use federal or state ~ OFFICIAL ~ G1/2H. - 28 (2) (a) The office, in consultation with the alliance,
- 29 shall prescribe the terms and conditions of the creation of the
- 30 system.
- 31 (b) The office and the alliance shall execute a
- 32 memorandum of understanding between them that details the scope of
- 33 work, anticipated outcomes and the timeline for developing the
- 34 prototype system.
- 35 (c) All agencies, institutions and departments that
- 36 sub-grant or contract with nonprofits for workforce or employment
- 37 services, and any nonprofit that receives such sub-grant or
- 38 contract, shall provide any information that may be requested from
- 39 the office or the alliance.
- 40 (3) The alliance shall provide a detailed report on the
- 41 progress and results of the prototype system to the office on a
- 42 quarterly basis. The office shall submit the report to the
- 43 Governor, Lieutenant Governor, Speaker of the House of
- 44 Representatives, Chair of the House Workforce Development
- 45 Committee and Chair of the Senate Economic and Workforce
- 46 Development Committee.
- 47 **SECTION 2.** This act shall take effect and be in force from
- 48 and after July 1, 2024.
