HOUSE BILL NO. 1311

AN ACT TO AMEND SECTION 37-103-25, MISSISSIPPI CODE OF 1972,
TO AUTHORIZE THE BOARD OF TRUSTEES OF COMMUNITY AND JUNIOR
COLLEGES WHICH BORDER ANOTHER STATE TO IMPLEMENT A POLICY FOR
REDUCING OR WAIVING OUT-OF-STATE TUITION FOR RESIDENTS OF THE
BORDERING STATE WHO RESIDE IN COUNTIES OR PARISHES ADJACENT TO THE
COMMUNITY COLLEGE DISTRICT; AND FOR RELATED PURPOSES.

- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 8 **SECTION 1.** Section 37-103-25, Mississippi Code of 1972, is
- 9 amended as follows:
- 10 37-103-25. (1) The Board of Trustees of State Institutions
- 11 of Higher Learning and the boards of trustees of the community
- 12 colleges and junior colleges are authorized to prescribe the
- 13 amount of tuition and fees to be paid by students attending the
- 14 several state-supported institutions of higher learning and
- 15 community colleges and junior colleges of the State of

- 16 Mississippi.
- 17 (2) Except as otherwise provided in this subsection and
- 18 subsections (3) and (4) of this section, the total tuition to be
- 19 paid by residents of other states shall not be less than the
- 20 average cost per student from appropriated funds. However, the

- 21 tuition to be paid by a resident of another state shall be equal
- 22 to the tuition amount established under subsection (1) of this
- 23 section if:
- 24 (a) The nonresident student is either a veteran, as
- 25 defined by Title 38 of the United States Code, or a person
- 26 entitled to education benefits under Title 38 of the United States
- 27 Code. Nonresident students enrolled in a professional school or
- 28 college at a state institution of higher learning are excluded
- 29 from this paragraph (2)(a) except for those nonresident students
- 30 who must be charged tuition equal to the amount established under
- 31 subsection (1) due to the provisions of Section 702 of the
- 32 Veterans Access, Choice and Accountability Act of 2014. This
- 33 paragraph (a) shall be administered and interpreted in the manner
- 34 necessary to obtain or retain approval of courses of education by
- 35 the Secretary of the United States Department of Veterans Affairs;
- 36 (b) The nonresident student is an evacuee of an area
- 37 affected by Hurricane Katrina or Hurricane Rita. This waiver
- 38 shall be applicable to the 2005-2006 school year only * * *; and
- 39 (c) The nonresident student's out-of-state tuition was
- 40 waived according to subsection (3) or (4) of this section.
- 41 (3) The Board of Trustees of State Institutions of Higher
- 42 Learning may, in its discretion, consider and grant requests to
- 43 approve institution specific policies permitting the waiver of
- 44 out-of-state tuition when such an official request is made by the
- 45 president or chancellor of the institution and when such request

- 46 is determined by the board to be fiscally responsible and in
- 47 accordance with the educational mission of the requesting
- 48 institution.
- 49 (4) (a) The board of trustees of any community college or
- 50 junior college may develop and implement a policy for waiving
- 51 out-of-state tuition for the college if the policy is determined
- 52 by the board to be in accordance with the educational mission of
- 53 the college and if a local industry or business or a state agency
- 54 agrees to reimburse the college for the entire amount of the
- 55 out-of-state tuition that will be waived under the policy. State
- 56 funds shall be allocated and spent only on students who reside
- 57 within the State of Mississippi. However, associate degree
- 58 nursing students who reside outside the State of Mississippi may
- 59 be counted for pay purposes.
- 60 (b) The board of trustees of any community college
- 61 located in a municipality or county which borders another state
- 62 may develop and implement a policy reducing or waiving
- 63 out-of-state tuition for residents who reside in counties or
- 64 parishes therein which border the respective community college
- 65 district for which such tuition policy is adopted. The policy may
- 66 include minimum criteria for student eligibility for the
- 67 out-of-state tuition waiver.
- 68 **SECTION 2.** This act shall take effect and be in force from
- 69 and after July 1, 2024.
