## HOUSE BILL NO. 1465

- AN ACT TO AMEND SECTION 23-15-563, MISSISSIPPI CODE OF 1972, TO CLARIFY THAT ONLY A CURRENT AND VALID MISSISSIPPI'S DRIVER'S LICENSE, NOT THE DRIVER'S LICENSE OF ANOTHER STATE, SHALL BE CONSIDERED FOR VOTER IDENTIFICATION PURPOSES; AND FOR RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 23-15-563, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 23-15-563. (1) Each person who appears to vote in person at
- 10 a polling place or the registrar's office shall be required to
- 11 identify himself or herself to a poll manager or the registrar by
- 12 presenting current and valid photo identification before such
- 13 person shall be allowed to vote.
- 14 (2) The identification required by subsection (1) of this
- 15 section shall include, but not be limited to, the following:
- 16 (a) A current and valid Mississippi driver's license,
- 17 no other state's driver's license shall be accepted;
- 18 (b) A current and valid identification card issued by a
- 19 branch, department, agency or entity of the State of Mississippi;

- 21 A current and valid employee identification card (d)
- 22 containing a photograph of the elector and issued by any branch,
- 23 department, agency or entity of the United States government, the
- 24 State of Mississippi, or any county, municipality, board,
- 25 authority or other entity of this state;
- 26 A current and valid Mississippi license to carry a
- pistol or revolver; 27
- 28 A valid tribal identification card containing a (f)
- 29 photograph of the elector;
- 30 A current and valid United States military
- identification card; 31
- 32 A current and valid student identification card, (h)
- containing a photograph of the elector, issued by any accredited 33
- college, university or community or junior college in the State of 34
- 35 Mississippi; and
- 36 An official Mississippi voter identification card
- containing a photograph of the elector. 37
- 38 (3) A person who appears to vote in person at a polling
- 39 place and does not have identification as required by this section
- 40 may vote by affidavit ballot. The affidavit ballot shall then be
- counted if the person shall present acceptable photo 41
- 42 identification to the registrar within five (5) days.
- 43 An elector who has a religious objection to being (b)
- photographed may vote by affidavit ballot, and the elector, within 44

- 45 five (5) days after the election, shall execute an affidavit in
- 46 the registrar's office affirming that the exemption applies.
- 47 (4) The intentional failure of an election official to
- 48 require a voter to present identification as required by this
- 49 section shall be considered corrupt conduct under Section 97-13-19
- 50 and shall be reported to the Secretary of State and the Attorney
- 51 General.
- 52 **SECTION 2.** This act shall take effect and be in force from
- 53 and after July 1, 2024.
