1 2 3	AN ACT MAKING AN APPROPRIATION FOR THE SUPPORT AND MAINTENANCE OF THE STATE FORESTRY COMMISSION FOR THE FISCAL YEAR 2025.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is appropriated out of any money in the State General
7	Fund not otherwise appropriated, for the support and maintenance
8	of the State Forestry Commission for the fiscal year beginning
9	July 1, 2024, and ending June 30, 2025
10	\$ 17,347,147.00.
11	SECTION 2. The following sum, or so much thereof as may be
12	necessary, is appropriated out of any money in the special fund in
13	the State Treasury to the credit of the State Forestry Commission
14	which is comprised of special source funds collected by or
15	otherwise available to the commission, for the support and
16	maintenance of the commission for the fiscal year beginning
17	July 1, 2024, and ending June 30, 2025\$ 14,220,094.00.

18 **SECTION 3.** Of the funds appropriated under the provisions of

- 19 this act, the following positions are authorized:
- 20 AUTHORIZED HEADCOUNT:
- 21 Permanent: 326
- 22 Time-Limited: 7
- With the funds herein appropriated, it shall be the agency's
- 24 responsibility to make certain that funds required for Personal
- 25 Services for Fiscal Year 2026 do not exceed Fiscal Year 2025 funds
- 26 appropriated for that purpose unless programs or positions are
- 27 added to the agency's Fiscal Year 2025 budget by the Mississippi
- 28 Legislature. The Legislature shall determine the agency's
- 29 personal services appropriation, which the State Personnel Board
- 30 shall publish. The agency's personal services appropriation may
- 31 consist of restricted funds for approved vacancies for Fiscal Year
- 32 2025 that may be utilized to fill vacant Fiscal Year 2024
- 33 headcount. It shall be the agency's responsibility to ensure that
- 34 the funds provided for vacancies are used to increase headcount
- 35 and not for promotions, title changes, in-range salary adjustments
- 36 or any other mechanism for increasing salaries for current
- 37 employees. It is the Legislature's intention that no employee
- 38 salary falls below the minimum salary established by the
- 39 Mississippi State Personnel Board.
- 40 Additionally, the State Personnel Board shall determine and
- 41 publish the projected annualized payroll costs based on current
- 42 employees. It shall be the responsibility of the agency head to

43	ensure	that	actual	personnel	expenditures	for	Fiscal	Year	2025	do

- 44 not exceed the data provided by the Legislative Budget Office. If
- 45 the agency's Fiscal Year 2025 projected cost exceeds the
- 46 annualized costs, no salary actions shall be processed by the
- 47 State Personnel Board except for new hires determined to be
- 48 essential for the agency.
- Any transfers or escalations shall be made in accordance with
- 50 the terms, conditions, and procedures established by law or
- 51 allowable under the terms set forth within this act. The State
- 52 Personnel Board shall not escalate positions without written
- 53 approval from the Department of Finance and Administration. The
- 54 Department of Finance and Administration shall not provide written
- 55 approval to escalate any funds for salaries and/or positions
- 56 without proof of availability of new or additional funds above the
- 57 appropriated level.
- No general funds authorized to be expended herein shall be
- 59 used to replace federal funds and/or other special funds used for
- 60 salaries authorized under the provisions of this act and which are
- 61 withdrawn and no longer available.
- None of the funds herein appropriated shall be used in
- 63 violation of the Internal Revenue Service's Publication 15-A
- 64 relating to the reporting of income paid to contract employees, as
- 65 interpreted by the Office of the State Auditor.
- With the funds appropriated herein, it shall be the agency's
- 67 responsibility to ensure that no employee in a job classification

68	with a minimum salary of Seventy Thousand Dollars (\$70,000.00) or
69	greater shall receive an in-range adjustment through progression,
70	equity, or immediate labor market increases.
71	SECTION 4. It is the intention of the Legislature that the
72	State Forestry Commission shall maintain complete accounting and
73	personnel records related to the expenditure of all funds
74	appropriated under this act and that such records shall be in the
75	same format and level of detail as maintained for Fiscal Year
76	2024. It is further the intention of the Legislature that the
77	agency's budget request for Fiscal Year 2026 shall be submitted to
78	the Joint Legislative Budget Committee in a format and level of
79	detail comparable to the format and level of detail provided
80	during the Fiscal Year 2025 budget request process.
81	SECTION 5. In compliance with the "Mississippi Performance
82	Budget and Strategic Planning Act of 1994," it is the intent of
83	the Legislature that the funds provided herein shall be utilized
84	in the most efficient and effective manner possible to achieve the
85	intended mission of this agency. Based on the funding authorized,
86	this agency shall make every effort to attain the targeted
87	performance measures provided below:

109	SECTION 6. Of the funds appropriated in Section	on 2, it is the
110	intention of the Legislature that Two Hundred Thousa	and Dollars
111	(\$200,000.00) shall be transferred to the Department	of
112	Agriculture and Commerce for the Beaver Control or E	Eradication
113	Program during the Fiscal Year 2025.	
114	SECTION 7. Any funds in the Salary, Wages and	Fringe
115	Benefits major object of expenditure may be used to	purchase
116	accumulated compensatory time within the funds avail	lable.

117	SECTION 8. It is the intention of the Legislature that
118	whenever two (2) or more bids are received by this agency for the
119	purchase of commodities or equipment, and whenever all things
120	stated in such received bids are equal with respect to price,
121	quality and service, the Mississippi Industries for the Blind
122	shall be given preference. A similar preference shall be given to
123	the Mississippi Industries for the Blind whenever purchases are
124	made without competitive bids.
125	SECTION 9. It is the intention of the Legislature that the
126	funds herein appropriated shall be expended in compliance with
127	Section 27-104-25, Mississippi Code of 1972, that no state agency
128	shall incur obligations or indebtedness in excess of their
129	appropriation and that the responsible officers, either personally
130	or upon their official bonds, shall be held responsible for
131	actions contrary to this provision.
132	SECTION 10. The money herein appropriated shall be paid by
133	the State Treasurer out of any money in the State Treasury to the
134	credit of the proper fund or funds as set forth in this act, upon
135	warrants issued by the State Fiscal Officer; and the State Fiscal
136	Officer shall issue his warrants upon requisitions signed by the
137	proper person, officer or officers, in the manner provided by law.
138	SECTION 11. This act shall take effect and be in force from
139	and after July 1, 2024.
