HOUSE BILL NO. 1842

1 AN ACT MAKING AN APPROPRIATION TO THE BOARD OF SUPERVISORS OF 2 CLAIBORNE COUNTY TO ASSIST IN PAYING COSTS ASSOCIATED WITH MAKING 3 UPGRADES AND IMPROVEMENTS TO PARKS AND RECREATIONAL AREAS AND 4 FACILITIES IN THE COUNTY FOR THE FISCAL YEAR 2025. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. The following sum, or so much of it as may be 6 7 necessary, is appropriated out of any money in the State General Fund not otherwise appropriated, to the Board of Supervisors of 8 9 Claiborne County, Mississippi, to assist in paying costs 10 associated with making upgrades and improvements to parks and recreational areas and facilities in the county, as provided in 11 12 Section 2, for the fiscal year beginning July 1, 2024, and ending June 30, 2025.....\$ 1,500,000.00 13 14 SECTION 2. The money appropriated by Section 1 shall be used for the following purposes: 15 (a) Upgrades and improvements to the Fairgrounds 16 17 baseball field lights, scoreboard and related facilities..... 18\$ 400,000.00

This act shall take effect and be in force from
