1 AN ACT MAKING AN APPROPRIATION TO THE MISSISSIPPI DEVELOPMENT 2 AUTHORITY FOR THE PURPOSE OF MAKING GRANTS UNDER THE MISSISSIPPI 3 MAIN STREET REVITALIZATION GRANT PROGRAM TO CERTAIN MAIN STREET 4 DESIGNATED COMMUNITIES FOR CERTAIN PROJECTS FOR THE FISCAL YEAR 5 2025. 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. The following sum, or so much of it as may be 8 necessary, is appropriated out of any money in the State General 9 Fund not otherwise appropriated, to the Mississippi Development 10 Authority for the purpose of making grants under the Mississippi Main Street Revitalization Grant Program established under 11 12 Sections 57-78-1 through 57-78-5, Mississippi Code of 1972, to certain Main Street Designated Communities for the projects 13 14 described in Section 2 of this act, for the fiscal year beginning 15 July 1, 2024, and ending June 30, 2025.....\$ 6,972,000.00. SECTION 2. The funds appropriated by Section 1 of this act 16 17 shall be distributed by the Mississippi Development Authority as grants to the following Main Street Designated Communities for the 18
