- 3 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
- 4 OF MISSISSIPPI, That the House of Representatives shall proceed to
- 5 the election of the Speaker, the Speaker Pro Tempore and the Clerk
- 6 of the House, as follows:
- 7 (a) Any candidate for the Office of Speaker, Speaker
- 8 Pro Tempore or Clerk who receives a majority of all votes cast in
- 9 any ballot shall be declared elected to the office. If, after the
- 10 first ballot, there is not one (1) candidate who has received a
- 11 majority of all votes cast, then the candidate receiving the
- 12 lowest number of votes shall be dropped on each succeeding ballot
- 13 until one (1) candidate receives a majority of all votes cast.
- 14 The vote for each office shall be by viva voce vote, with the roll
- 15 of members called by house district numbers in ascending order.
- 16 (b) In balloting for the Office of Speaker Pro Tempore
- 17 and the Clerk, the Speaker shall not vote unless there is a tie

18 vote. If there is a tie vote on any ballot for those offices, the

- 19 Speaker shall cast the deciding vote between the candidates having
- 20 an equal number of votes.
- 21 BE IT FURTHER RESOLVED, That in nominating candidates for the
- 22 Offices of Speaker, Speaker Pro Tempore and Clerk, the speeches
- 23 shall be limited as follows:
- 24 (a) For the Office of Speaker, the speeches shall be
- 25 limited to one (1) nominating speech and two (2) seconding
- 26 speeches for each candidate, and no nominating speech shall be for
- 27 more than five (5) minutes and no seconding speech shall be for
- 28 more than three (3) minutes.
- 29 (b) For the Office of Speaker Pro Tempore, the speeches
- 30 shall be limited to one (1) nominating speech and one (1)
- 31 seconding speech for each candidate, and no nominating speech
- 32 shall be for more than five (5) minutes and no seconding speech
- 33 shall be for more than three (3) minutes.
- 34 (c) For the Office of Clerk, the speeches shall be
- 35 limited to one (1) nominating speech and one (1) seconding speech
- 36 for each candidate, and no nominating or seconding speech shall be
- 37 for more than three (3) minutes.
