1 A RESOLUTION COMMENDING AND CONGRATULATING HARRISON COUNTY 2 SHERIFF TROY J. PETERSON UPON THE OCCASION OF HIS RETIREMENT FROM 3 THE HARRISON COUNTY SHERIFF'S OFFICE AFTER 29 YEARS OF SELFLESS SERVICE. WHEREAS, Harrison County Sheriff, Mr. Troy J. Peterson, an 5 exemplary public servant, is retiring from the Harrison County 6 7 Sheriff's Office, hanging up his gun and badge, after dedicating 29 years of illustrious service and devotion to the citizens of 8 9 Harrison County and the State of Mississippi; and 10 WHEREAS, Sheriff Peterson received his associate degree in criminal justice from Mississippi Gulf Coast Community College and 11 12 furthered his education at the University of Southern Mississippi, where he received his bachelor of science degree in criminal 13

WHEREAS, before joining the Harrison County Sheriff's Office,

- 22 WHEREAS, Sheriff Peterson joined the Harrison County
- 23 Sheriff's Office in 1994 and served as a deputy in the Corrections
- 24 and Patrol Divisions until he became a narcotics investigator in
- 25 1998; and
- 26 WHEREAS, for the next 10 years, he bravely conducted
- 27 narcotics investigations as a member of the Narcotics Division,
- 28 the Coastal Narcotics Enforcement Team (CNET) and the United
- 29 States Drug Enforcement Administration, HIDTA Divisions, and as a
- 30 Special Weapons and Tactics (SWAT) Team operator, he participated
- 31 in the disrupting and dismantling of drug organizations
- 32 responsible for trafficking narcotics across the United States and
- 33 into the southern region of Mississippi; and
- 34 WHEREAS, in 2008, he was promoted to Captain Peterson, and
- 35 became responsible for the daily operations of the Narcotics
- 36 Division and CNET, including 24 sworn officers as well as civilian
- 37 personnel, and he also attended the United States Drug Enforcement
- 38 Drug Unit Commander Academy in Quantico, Virginia; and
- 39 WHEREAS, Mr. Troy J. Peterson became the Sheriff of Harrison
- 40 County in 2016, and through that role, he was responsible for
- 41 daily operations at the Harrison County Sheriff's Office and the
- 42 Harrison County Adult Detention Center; he managed a 26.7 million
- 43 dollar budget; and he was responsible for legislative and
- 44 governmental affairs, contributed to strategic planning and

- 47 WHEREAS, as the head of the Harrison County Sheriff's Office,
- 48 Sheriff Peterson faced dangerous, deadly situations every day that
- 49 demanded he put his life on the line, but every time the call

- 51 and courageously fought the most threatening people, places and
- 52 happenings to ensure safety for the citizens of Mississippi, who
- 53 will be forever grateful for his intrepid, noble efforts; and
- 54 WHEREAS, the longevity of Sheriff Peterson's career has been
- 55 marked with notable accomplishments and awards, including the Law
- 56 Enforcement Coordinator Lifetime Achievement Award by the
- 57 Mississippi Coast Crime Stoppers in 2019; the Service of Duty
- 58 Award in 2008 and the HIDTA Office of the Year Award in 2019, both
- 59 by the United States Drug Enforcement Administration; the
- 60 Distinguished Service Award by the Mississippi Bureau of Narcotics
- 61 in 2015; the Outstanding Narcotics Officer of the Year Award by
- 62 the Harrison County Sheriff's Office in 1999; and the Army
- 63 Achievement Medal by the United States Army in 1990 and 1991; and
- 64 WHEREAS, Sheriff Peterson has also filled a number of
- 65 leadership roles during his tenure, including serving on the
- 66 Oversight Commission for Corrections as the Lieutenant Governor's
- 67 appointment; Vice President of the Mississippi Sheriff's
- 68 Association; Vice President of the Mississippi Association of Drug

- 69 Enforcement Officers; and Commissioner of the Mississippi Wireless
- 70 Communications Commission; and
- 71 WHEREAS, in his spare time, Sheriff Peterson is a member of
- 72 Holy Family Catholic Church, OUPV Boat Captain and the Revelers
- 73 Carnival Association; and
- 74 WHEREAS, Sheriff Peterson has been an exceptional sheriff and
- meritorious leader to the people of the Harrison County Sheriff's 75
- 76 Office and throughout this great state, and his indomitable grit,
- 77 dexterous abilities and passionate determination will be dearly
- 78 missed by all of his colleagues and others who were fortunate to
- 79 have the privileged opportunity to work with him and experience
- 80 his greatness; and
- 81 WHEREAS, it is the policy of the House of Representatives to
- pay tribute to fine, heroic Mississippians such as Harrison County 82
- 83 Sheriff Troy J. Peterson, a man consumed with a selfless drive to
