HOUSE RESOLUTION NO. 42

A RESOLUTION COMMENDING AND CONGRATULATING CHRISTOPHER BROWN, UPON EARNING THE EAGLE SCOUT AWARD, AND EXTENDING SINCEREST WISHES FOR CONTINUED SUCCESS IN ALL HIS FUTURE ENDEAVORS.

- 4 WHEREAS, Black History Month is an annual celebration of
- 5 achievements by Black Americans and a time for recognizing the
- 6 central role of African Americans in United States history; and
- 7 WHEREAS, in 1976, President Gerald R. Ford urged Americans to
- 8 "seize the opportunity to honor the too-often neglected
- 9 accomplishments of the Black Americans in every area of endeavor
- 10 throughout our history"; and
- 11 WHEREAS, on June 8, 1926, Edgar Cunningham Sr., became the
- 12 first African-American Eagle Scout, as a member of Troop 12, in
- 13 Waterloo, Iowa, of the Wapsipinicon Area Council, under the
- 14 leadership of scoutmaster James Lincoln Page, a World War I
- 15 veteran, who organized the first all-Black Boy Scout Troops, which
- 16 were Troops 9 and 10, on February 10, 1925; and
- 17 WHEREAS, the title of Eagle Scout is the highest rank
- 18 attainable in the scouting program of the Boy Scouts of America

- 19 (BSA), awarded to any boy scout who has earned 21 merit badges and
- 20 demonstrated Scout Spirit through the Boy Scout Oath and Law,
- 21 service and leadership, which include an execution of an extensive
- 22 service project that the scout plans, organizes, leads and
- 23 manages; and
- 24 WHEREAS, completion of these important community projects are
- 25 used to assess the scout's demonstration of leadership and
- 26 commitment to duty, and often benefit religious institutions,
- 27 schools and the community, without inuring the benefit of the Boy
- 28 Scouts or be of a commercial nature; and
- 29 WHEREAS, Eagle Scouts are presented with a medal and a badge
- 30 that visibly recognizes the accomplishments of the scout, and
- 31 additional recognition can be earned through Eagle Palms, awarded
- 32 for completing additional tenure, leadership, and merit badge
- 33 requirements; and
- 34 WHEREAS, Christopher Brown has fulfilled his duties and
- 35 obligations of maintaining and promoting the mission and vision of
- 36 the Boy Scouts of America by earning the required 21 merit badges,
- 37 while maintaining "B" academic honors as a junior at West Jones
- 38 High School; and
- 39 WHEREAS, a member of the Culinary Arts Department with the
- 40 West Jones' vocational and technical education team, Christopher's
- 41 church, West Pleasant Grove Missionary Baptist Church, is a
- 42 constant source of encouragement, and reinforces the achievements
- 43 and accomplishments of this young African-American man in

- 45 African-American Eagle Scout, Edgar Cunningham Sr.; and
- 46 WHEREAS, on Sunday, February 25, 2024, Christopher Brown will
- 47 join the elite ranks of the proud few who have earned the
- 48 distinguished honor of being bestowed the title of Eagle Scout;
- 49 and
- 50 WHEREAS, it is the policy of the House of Representatives to
- 51 commend young Mississippians, such as Christopher Brown, who has
- 52 attained scouting's highest rank and in doing so, brought honor to
- 53 his family, school, community and the State of Mississippi:
- NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
- 55 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, That we do hereby
- 56 commend and congratulate Christopher Brown, upon earning the Eagle
- 57 Scout Award, and extend sincerest wishes for continued success in
- 58 all his future endeavors.
