5	WHEREAS, Ehlers-Danlos syndromes (EDS) are a group of 13
6	heritable connective tissue disorders that together affect 1 in
7	5,000 people; and
8	WHEREAS, each type of EDS has its own set of symptoms, but
9	some features are seen across all types of EDS, including joint
10	hypermobility, skin hyperextensibility and tissue fragility; and
11	WHEREAS, hypermobility spectrum disorders (HSD) are
12	connective tissue disorders that cause joint hypermobility,
13	instability, injury and pain, as well as other symptoms, such as
14	fatigue, headaches, gastrointestinal problems and autonomic
15	dysfunction, which have been associated indicators of HSD; and
16	WHEREAS, there is no cure for any type of EDS or HSD,
17	however, the conditions are managed by addressing an individual's

symptoms; and

19	WHEREAS, EDS and HSD can cause a variety of symptoms in many
20	different areas of the body, so people with these conditions often
21	require multiple providers in different specialties to manage
22	their care; and
23	WHEREAS, access to professionals who are knowledgeable about
24	EDS and HSD is limited in the State of Mississippi, and this lack
25	of awareness about EDS and HSD in the State of Mississippi and
26	across the world provides a hinderance to the diagnosis,
27	management and research of these conditions; and
28	WHEREAS, awareness about EDS and HSD by both medical
29	professionals and the general public can help improve the lives of
30	people living with EDS and HSD in the State of Mississippi; and
31	WHEREAS, the month of May would be an appropriate month to
32	designate as Ehlers-Danlos Syndrome and Hypermobility Spectrum
33	Disorders Awareness in evidence the House of Representatives'
34	support of honoring those brave souls suffering from Ehlers-Danlos
35	Syndrome and Hypermobility Spectrum Disorders:
