HOUSE RESOLUTION NO. 107

- A RESOLUTION HONORING THE LIFE AND LEGACY OF CHIEF WILLIAM ANTHONY ANDERSON, SR., AND EXPRESSING DEEPEST SYMPATHY TO HIS
- 3 FAMILY AND FRIENDS UPON HIS PASSING.
- 4 WHEREAS, it is written in Ecclesiastes 3:1 that "To
- 5 everything there is a season, and a time for every purpose under
- 6 the Heaven," and as such, on Saturday, March 9, 2024, the
- 7 immaculate author and finisher of our soul's destiny summoned the
- 8 mortal presence of dearly beloved, Chief William Anthony Anderson,
- 9 Sr., of New Albany, Mississippi, to eternal rest, rendering great
- 10 sorrow and loss to his family, friends and community; and
- 11 WHEREAS, born on July 12, 1962, to the late Mr. William
- 12 (W.M.) Anderson and Mrs. Ilene Anderson, Chief Anderson was a 1981
- 13 graduate of East Union Attendance Center and received an associate
- 14 degree from Northeast Mississippi Junior College before attending
- 15 Middle Tennessee State University; and
- WHEREAS, true love struck, and on September 27, 1985, Chief
- 17 Anderson exchanged the vows of holy matrimony with Ms. Constance

- 18 (Connie) Vernatt Smith, and they were blessed with three children,
- 19 Anna, Ebony and William, who is also in law enforcement; and
- 20 WHEREAS, at an early age, Chief Anderson accepted Christ as
- 21 his savior at Oak Grove Missionary Baptist Church, where he and
- 22 his wife were active and dedicated members for many years, and
- 23 while there, he served on the Deacon Board, and later, he and his
- 24 wife joined Ecru Second Baptist Church, where he served as a
- 25 Deacon, Assistant Church Treasurer, Outreach Team Liaison and a
- 26 reliable liaison for the Music Ministry, and as he faithfully
- 27 served wherever he was needed, he was a member of Project Domino,
- 28 the Man-Up Organization, and the Masonic Lodge 171 in New Albany;
- 29 and
- 30 WHEREAS, Chief Anderson was in his twenty-fourth year in law
- 31 enforcement after graduating from the North Mississippi Law
- 32 Enforcement Academy in 2000, and previously worked for the Union
- 33 County Sheriff's Department for 12 years, and he also served a
- 34 three-year stint as the chief of police for the city of Verona,
- 35 Mississippi, before joining the Northeast Mississippi Community
- 36 College police department full time in 2014; and
- 37 WHEREAS, during his time with the Union County Sheriff's
- 38 Department, Chief Anderson worked as a field deputy and an
- 39 investigator who focused on sex crimes and crimes against
- 40 vulnerable adults and children, and he was a member of the Union
- 41 County Urban Search and Rescue squad as well as a member of the
- 42 Union County SWAT team; and

43	WHEREAS, as the chief of police for Verona, Chief Anderson
44	was instrumental in hiring over 20 reserve officers for the
45	growing police department and helping to reduce the crime rate in
46	the city; and
47	WHEREAS, as a former Northeast Mississippi Community College
48	Tiger basketball standout, during his time on the hardwood, Chief
49	Anderson expressed his basketball prowess and led Northeast to
50	over 40 wins in his two years, and during his first year at
51	Northeast, the Tigers rallied to win the state championship
52	against Hinds Community College in Utica 86-78; and
53	WHEREAS, in his sophomore season, Chief Anderson helped
54	Northeast land the inaugural National Junior College Athletic
55	Association (NJCAA) Region XXIII Tournament, where he scored a
56	game-best 45 points including a 20-for-22 showing from the charity
57	stripe against Delgado Community College of Louisiana in the
58	opening round of the regional tournament; and
59	WHEREAS, Chief Anderson scored a career-high 46 points versus
60	the now-defunct Mary Holmes College on January 15, 1983, and those
61	performances are still two of the top 10 scoring games for any
62	Northeast athlete over the last 40 years; and
63	WHEREAS, Chief Anderson finished the season as the leading
64	scorer in the NJCAA Region XXIII with 793 points and was also
65	ranked amongst the top 10 rebounders in the conference as a
66	sophomore; and

67	WHEREAS, Chief Anderson was named the Babe McCarthy Junior
68	College Player of the Year, which is awarded to the top athlete at
69	the two-year level in Mississippi, an NJCAA All-American, and was
70	voted by his teammates and Coach Richard Mathis as Northeast's
71	Most Valuable Player following his sophomore season; and
72	WHEREAS, Chief Anderson accumulated 1,098 total points in a
73	black-and-gold uniform, despite not benefitting from a three-point
74	line, and he used free throws to his advantage instead with 155
75	makes during the 1982-83 campaign alone, and in 2023, he was
76	inducted into the Mississippi Association of Community Colleges
77	Conference (MACCC) Hall of Fame; and
78	WHEREAS, devoted to campus safety, Chief Anderson assumed
79	command of the Northeast Mississippi Community College Campus
80	Police Department on July 1, 2023, after the retirement of
81	longtime chief of police Randy Baxter; and
82	WHEREAS, Chief Anderson, who served as assistant chief under
83	former Chief Baxter, led the campus' police department that
84	provides security and safety for all college facilities along with
85	assistance to college employees, students, visitors and community
86	members 24 hours a day, seven days a week; and
87	WHEREAS, Chief Anderson was instrumental in updating the
88	campus safety plan, providing professional development on campus
89	safety and instrumenting new policies that helped the college's
90	police department function more efficiently, and he and his staff
91	made sure that Northeast's employees, students and community

93	students before they left for Spring Break; and
94	WHEREAS, as a leader, mentor, counselor and encourager to
95	young people all over the area, Chief Anderson used his allotted
96	time to serve God and his community, and his legacy of service and
97	dedication to safety will live on through those he served, and his
98	"never met a stranger" personality, easy smile and professional
99	demeanor will always be remembered in the hearts of those he
100	protected and inspired; and
101	WHEREAS, a genuine man of exceptional character, Chief
102	Anderson's outstanding legacy will continue for generations to
103	come, and precious memories of time spent with him will hopefully
104	continue to provide warmth, peace and comfort to his loved ones;

106	WHEREAS, though he has traversed the river of life to reunite
107	with those who answered God's summons to life eternal and now
108	beckon his arrival to the celestial shores of Heaven's grandeur,
109	such as his parents, Mr. William (W.M.) Anderson and Mrs. Ilene
110	Anderson; the legacy of Chief Anderson's indelible imprint upon
111	our lives will continue to refresh the hearts and fond memories of
112	his loved ones, including his wife, Mrs. Connie Anderson;
