SENATE BILL NO. 2185

AN ACT TO REQUIRE THE DEPARTMENT OF CORRECTIONS TO NOTIFY THE
DEPARTMENT OF PUBLIC SAFETY ON A WEEKLY BASIS OF ALL PROBATION AND
PAROLE STATUSES; TO REQUIRE THE DEPARTMENT OF PUBLIC SAFETY TO
INCLUDE THE PAROLE AND PROBATION DATA OF A LICENSEE OR APPLICANT
FOR A STATE-ISSUED PHOTO IDENTIFICATION CARD, IF THERE IS ANY SUCH
DATA, WITHIN THE INFORMATION CONTAINED IN THE MAGNETIC STRIP OF
ANY LICENSE OR IDENTIFICATION CARD ISSUED IN THE STATE; TO AMEND
SECTIONS 45-35-5, 45-35-53 AND 45-35-71, MISSISSIPPI CODE OF 1972,
TO CONFORM; AND FOR RELATED PURPOSES.

- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 **SECTION 1.** The Department of Corrections shall notify the
- 12 Department of Public Safety on a weekly basis of all probation and
- 13 parole statuses. The Department of Public Safety shall include
- 14 the parole and probation data of a licensee, if there is any such
- 15 data, within the information contained in the magnetic strip of
- 16 any license issued under the authority of Title 63, Chapter 1,
- 17 Mississippi Code of 1972. The Department of Public Safety shall
- 18 ensure that the probation and parole data under this section shall
- 19 not appear within the information contained in the magnetic strip
- 20 once a person is no longer on probation or parole under the
- 21 authority of the Department of Corrections.

- SECTION 2. Section 45-35-5, Mississippi Code of 1972, is
- 23 amended as follows:
- 24 45-35-5. (1) Data for the issuance of an identification
- 25 card shall include a birth certificate or other document to
- 26 establish the age and identity of the applicant, the social
- 27 security number of the applicant, and such other identifying data
- 28 as is required on an application for issuance of a driver's
- 29 license.
- 30 (2) The department shall include the probation and parole
- 31 data of an applicant, if there is any such data, in the
- 32 information contained in the magnetic strip of any identification
- 33 card issued under the authority of this section pursuant to the
- 34 procedure provided in Section 1 of this act.
- 35 **SECTION 3.** Section 45-35-53, Mississippi Code of 1972, is
- 36 amended as follows:
- 37 45-35-53. (1) The Department of Public Safety shall issue
- 38 personal identification cards to persons with disabilities who
- 39 make application to the department in accordance with rules and
- 40 regulations prescribed by the commissioner by filing with the
- 41 Secretary of State under the Administrative Procedures Act. The
- 42 identification card for persons with disabilities shall
- 43 prominently display the international handicapped symbol and, in
- 44 addition to any other information required by this article, may
- 45 contain a recent color photograph of the applicant and the
- 46 following information:

- 74 **SECTION 4.** Section 45-35-71, Mississippi Code of 1972, is
- 75 amended as follows:
- 76 45-35-71. The Department of Public Safety shall be the state
- 77 agency with responsibility for regulating a digital wallet for
- 78 state agency credentials. The Commissioner of Public Safety may
- 79 promulgate rules and regulations regarding such digital wallet
- 80 technology. The commissioner shall ensure that the probation and
- 81 parole data of an applicant, if there is any such data, shall be
- 82 included in the information contained in such digital wallet
- 83 pursuant to the procedure provided in Section 1 of this act.
- 84 **SECTION 5.** This act shall take effect and be in force from
- 85 and after July 1, 2024.
