## SENATE BILL NO. 2230

- AN ACT TO AMEND SECTION 3-3-7, MISSISSIPPI CODE OF 1972, TO REVISE THE LEGAL HOLIDAYS BY REMOVING CONFEDERATE MEMORIAL DAY AND DESIGNATING THE NINETEENTH DAY OF JUNE AS JUNETEENTH FREEDOM DAY; TO CLARIFY WHEN A LEGAL HOLIDAY WILL BE CELEBRATED IF THE HOLIDAY FALLS ON A SATURDAY OR SUNDAY; AND FOR RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 3-3-7, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 3-3-7. (1) Except as otherwise provided in subsection (2)
- 10 of this section, the following are declared to be legal holidays,
- 11 viz:
- 12 (a) The first day of January, designated as New Year's
- 13 Day;
- 14 (b) The third Monday of January, designated as both
- 15 Robert E. Lee's birthday and Dr. Martin Luther King, Jr.'s
- 16 birthday;
- 17 (c) The third Monday of February, designated as George
- 18 Washington's birthday;

- 27 Day;
- 28 (h) The eleventh day of November, designated as

- 40 (2) In lieu of any one (1) legal holiday provided for in
- 41 subsection (1) of this section, with the exception of the third
- 42 Monday in January, designated as both Robert E. Lee's and Martin
- 43 Luther King, Jr.'s birthday, and the eleventh day of November,
- 44 designated as Armistice or Veterans' Day, the governing

- 45 authorities of any municipality or county may declare, by order
- 46 spread upon its minutes, Mardi Gras Day or any one (1) other day
- 47 during the year, to be a legal holiday.
- 48 (3) August 16 is declared to be Elvis Aaron Presley Day in
- 49 recognition and appreciation of Elvis Aaron Presley's many
- 50 contributions, international recognition and the rich legacy left
- 51 to us by Elvis Aaron Presley. This day shall be a day of
- 52 recognition and observation and shall not be recognized as a legal
- 53 holiday.
- 54 (4) May 8 is declared to be Hernando de Soto Day in
- 55 recognition, observation and commemoration of Hernando de Soto,
- 56 who led the first and most imposing expedition ever made by
- 57 Europeans into the wilds of North America and the State of
- 58 Mississippi, and in further recognition of the Spanish explorer's
- 59 187-day journey from the Tombigbee River basin on our state's
- 60 eastern boundary, westward to the place of discovery of the
- 61 Mississippi River on May 8, 1541. This day shall be a day of
- 62 commemoration, recognition and observation of Hernando de Soto and
- 63 European exploration and shall not be recognized as a legal
- 64 holiday.
- 65 (5) Armistice Day or Veterans' Day shall be observed by
- 66 appropriate exercises in all the public schools in the State of
- 67 Mississippi. The superintendent of schools of each public school
- 68 district is authorized to provide for the appearance of uniformed
- 69 military personnel, uniformed veterans or the families of fallen

- 70 military personnel/veterans at such public school exercises in
- 71 honor of Armistice or Veterans' Day. The superintendent of
- 72 schools is also authorized to permit the school band and its
- 73 director(s) at any public school in the district to perform at
- 74 Armistice or Veterans' Day exercises in the school district upon
- 75 the request of public officials or veterans associations without
- 76 loss of any program credit by participating students and without
- 77 loss of leave by participating school personnel.
- 78 **SECTION 2.** This act shall take effect and be in force from
- 79 and after its passage.
