1 2 3 4	AN ACT TO AUTHORIZE THE DEPARTMENT OF PUBLIC SAFETY TO PURCHASE CERTAIN REAL PROPERTY, AND ANY IMPROVEMENTS THEREON, LOCATED ON BELK BOULEVARD IN OXFORD, MISSISSIPPI, KNOWN AS THE FORMER "RAYNER EYE CLINIC"; AND FOR RELATED PURPOSES.											
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:											
6	SECTION 1. (1) The Department of Public Safety is											
7	authorized to purchase certain real property, and any improvements											
8	thereon, located in Oxford, Mississippi, known as the former											
9	"Rayner Eye Clinic," and being more particularly described as											
10	follows:											
11	Property located at 1308 Belk Boulevard, Oxford, Mississippi,											
12	consisting of one (1) parcel and identified as:											
13	Parcel 1											
14	Fraction of the North Half Section 33, Township 8											
15	South, Range 3 West, Lafayette Country, Mississippi.											
16	This property contains 1.095 acres, more or less and is											
17	described in more detail as follows:

- 76 (2) The real property and improvements described in
- 77 subsection (1) of this section shall not be purchased for an
- 78 amount greater than the current fair market value as
- 79 determined by the average of two (2) appraisals by qualified
- 80 appraisers, at least one (1) of whom shall be selected by the
- 81 Department of Public Safety, and both of whom shall be
- 82 certified and licensed by the Mississippi Real Estate
- 83 Appraiser Licensing and Certification Board.
- 84 (3) The Department of Public Safety is authorized to
- 85 negotiate any and all closing costs related to the
- 86 acquisition of these properties.
- 87 (4) The Department of Public Safety may correct any
- 88 discrepancies in the legal descriptions of the property
- 89 provided in this section.
- 90 (5) The real property and improvements acquired under
- 91 this section shall be used exclusively for state office space
- 92 and parking purposes.
- 93 **SECTION 2.** This act shall take effect and be in force
- 94 from and after its passage.
