## SENATE BILL NO. 2600

1 AN ACT TO CREATE A STUDY COMMITTEE TO STUDY MOVING PAROLE AND 2 PROBATION OFFICERS AND ASSOCIATED SUPPORT STAFF FROM THE COMMUNITY 3 CORRECTIONS DIVISION OF THE MISSISSIPPI DEPARTMENT OF CORRECTIONS TO THE MISSISSIPPI DEPARTMENT OF PUBLIC SAFETY; AND FOR RELATED 5 PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** (1) There is created a study committee for the
- 8 purpose of studying the moving of the parole and probation
- officers and support staff whose duty is monitoring the formerly
- 10 incarcerated individuals on parole or post-release supervision in
- the pursuit of the reduction of recidivism and increased workforce 11
- 12 participation of the formerly incarcerated through targeted
- support, education, training and supervision and for recommending 13
- 14 solutions, from the Community Corrections Division of the
- 15 Mississippi Department of Corrections to the Mississippi
- Department of Public Safety. 16
- 17 (2) The committee shall be comprised of the following nine
- 18 (9) members:

- 21 (b) Three (3) members of the Mississippi House, to be 22 appointed by the Speaker of the House of Representatives;
- 23 (c) The Commissioner of the Mississippi Department of 24 Corrections, or a designee, as an ex officio nonvoting member;
- 25 (d) The Chairman of the Mississippi Parole Board, or a 26 designee, as an ex officio nonvoting member; and
- 27 (e) The Commissioner of the Mississippi Department of 28 Public Safety, or a designee, as an ex officio nonvoting member.
- 29 (3) Appointments to the study committee shall be made within 30 thirty (30) days of the effective date of this act. At the first 31 meeting, the committee shall elect from among its members a 32 chairman, a vice chairman and any other officers determined to be 33 necessary, and shall adopt rules for transacting business and 34 keeping records. The study committee shall develop and report its

findings to the Legislature on or before December 1, 2024.

- 36 (4) A majority of the members of the study committee shall 37 constitute a quorum. In the adoption of rules, resolutions and 38 reports, and in the election of a chairman, vice chairman and any 39 other officers determined to be necessary, an affirmative vote of 40 a majority of the members present shall be required.
- 41 (5) The Commissioner of the Department of Corrections shall 42 provide the staff and other support necessary for the study 43 committee to perform its duties.
