1 AN ACT TO CREATE SECTION 81-5-109, MISSISSIPPI CODE OF 1972, TO REQUIRE BANKS TO REPORT SUSPECTED FRAUDULENT WIRE TRANSFERS OF 2 3 \$10,000.00 OR MORE TO THE SECRET SERVICE AND MISSISSIPPI OFFICE OF HOMELAND SECURITY WITHIN 24 HOURS OF NOTICE; AND FOR RELATED 5 PURPOSES.

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6
- 7 SECTION 1. The following shall be codified as Section
- 81-5-107, Mississippi Code of 1972: 8
- 81-5-107. (1) For the purpose of this section, notice shall 9
- 10 mean:
- 11 (a) Communication between a depositor and a banking
- 12 institution, or their representative, whether via in-person,
- telephone or some form of electronic communication, where the 13
- depositor expresses concern about a fraudulent charge or transfer 14
- 15 made from their account with the banking institution; or
- 16 (b) Where security software or measures utilized by the
- 17 banking institution detect and report an incident of potentially
- fraudulent activity within a client account or client accounts. 18

- 20 suspected fraudulent wire transfer or charge of Ten Thousand
- 21 Dollars (\$10,000.00) or more, a bank shall notify the United
- 22 States Secret Service and the Mississippi Office of Homeland
- 23 Security of the suspected fraud within twenty-four (24) hours of
- 24 the bank receiving notice. If the fraud detection was made by
- 25 security software utilized by the banking institution, the bank
- 26 shall notify the depositor via a phone call and electronic mail,
- 27 or by mail if an email address is not provided, within twenty-four
- 28 (24) hours of receiving notice of suspected fraud.
- 29 (3) Upon the conclusion of the investigation of fraud, the
- 30 depositor shall be provided with a written report by electronic
- 31 mail and by mail, if both are possible, within five (5) business
- 32 days after a determination has been made.
- 33 (4) Failure of a bank to provide such notice to the United
- 34 States Secret Service and the Mississippi Office of Homeland
- 35 Security shall result in a fine not to exceed Two Hundred Fifty
- 36 Dollars (\$250.00). The fine shall be enforced and made payable to
- 37 the Department of Bank Supervision.

- 39 and after July 1, 2024.
