1 AN ACT TO AMEND SECTION 39-11-13, MISSISSIPPI CODE OF 1972, 2 TO AUTHORIZE THE MISSISSIPPI ARTS COMMISSION TO RETAIN A 3 PERCENTAGE AMOUNT OF THE MONIES IN THE BUILDING FUND FOR THE ARTS 4 TO DEFRAY ADMINISTRATIVE COSTS ASSOCIATED WITH ADMINISTERING THE 5 GRANT PROGRAM UNDER THIS SECTION; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 7 SECTION 1. Section 39-11-13, Mississippi Code of 1972, is 8 amended as follows: 9 39-11-13. (1) (a) A special fund, to be designated as the 10 "Building Fund for the Arts," is created within the State 11 Treasury. The fund shall be maintained by the State Treasurer as 12 a separate and special fund, separate and apart from the General Fund of the state. The fund shall consist of any money designated 13 for deposit therein from any source, including, but not limited 14

to, any state general obligation bonds issued for the purposes

described in this section. Unexpended amounts remaining in the

fund at the end of a fiscal year shall not lapse into the State

General Fund, and investment earnings on amounts in the fund shall

be deposited into such fund.

70	(3) The Mississippi Arts Commission is expressly authorized
71	and empowered to receive and expend any local or other source
72	funds in connection with the expenditure of funds provided for in
73	this section. The expenditure of money deposited into the special
74	fund shall be under the direction of the Mississippi Arts
75	Commission, and such funds shall be paid by the State Treasurer
76	upon warrants issued by the Department of Finance and
77	Administration upon request of the Mississippi Arts Commission,
78	which warrants shall be issued upon requisitions signed by the
79	Executive Director of the Mississippi Arts Commission, or his or
80	her designee. The Mississippi Arts Commission may retain an
81	amount not to exceed one percent (1%) of the monies in the fund to
82	defray administrative costs associated with administering the

(4) The Mississippi Arts Commission shall adopt necessary rules and regulations to govern the administration of the program described in subsection (1) of this section, including, but not limited to, rules and regulations governing applications for grants and rules and regulations providing for the distribution of grant funds. The Mississippi Arts Commission shall comply with the provisions of the Mississippi Administrative Procedures Law.
