1 AN ACT TO AMEND SECTION 28, CHAPTER 549, LAWS OF 2023, TO  
 2 MAKE TECHNICAL AMENDMENTS TO CLARIFY AND CORRECT CERTAIN NAMES AND  
 3 PURPOSES OF VARIOUS PROJECTS FUNDED FROM DISBURSEMENTS FROM THE  
 4 2023 LOCAL IMPROVEMENTS PROJECT FUND; TO AMEND SECTION 4, CHAPTER  
 5 549, LAWS OF 2023, TO AMEND THE PURPOSE OF THE USE OF FUNDS  
 6 RECEIVED BY JACKSON STATE UNIVERSITY FROM THE 2022 IHL CAPITAL  
 7 IMPROVEMENTS FUND; TO AMEND SECTION 65-1-185, MISSISSIPPI CODE OF  
 8 1972, TO DELETE THE PROVISION REFERENCING THE DEPARTMENT OF  
 9 FINANCE AND ADMINISTRATION AND APPROPRIATION BY THE LEGISLATURE  
 10 FROM THE PROCEDURE FOR THE USE OF FUNDS FROM THE 2023 DESOTO  
 11 COUNTY INFRASTRUCTURE IMPROVEMENTS FUND; TO AMEND SECTION  
 12 65-1-187, MISSISSIPPI CODE OF 1972, TO DELETE THE PROVISION  
 13 REFERENCING THE DEPARTMENT OF FINANCE AND ADMINISTRATION AND  
 14 APPROPRIATION BY THE LEGISLATURE FROM THE PROCEDURE FOR THE USE OF  
 15 FUNDS FROM THE 2023 LAFAYETTE COUNTY INFRASTRUCTURE IMPROVEMENTS  
 16 FUND; TO AMEND SECTION 65-1-189, MISSISSIPPI CODE OF 1972, TO  
 17 DELETE THE PROVISION REFERENCING THE DEPARTMENT OF FINANCE AND  
 18 ADMINISTRATION AND APPROPRIATION BY THE LEGISLATURE FROM THE  
 19 PROCEDURE FOR THE USE OF FUNDS FROM THE 2023 GULFPORT COMMERCE  
 20 CORRIDOR FUND; AND FOR RELATED PURPOSES.

21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

22 **SECTION 1.** Section 28, Chapter 549, Laws of 2023, is amended  
 23 as follows:

24 Section 28. Monies transferred pursuant to Sections 1 and 3  
 25 of this act into the 2023 Local Improvements Projects Fund shall  
 26 be disbursed by the Department of Finance and Administration,

1619 the Legislature in any manner and funds from any other source  
1620 designated for deposit into such fund. The fund shall be  
1621 maintained by the State Treasurer as a separate and special fund,

1632 **SECTION 5.** Section 65-1-189, Mississippi Code of 1972, is  
1633 amended as follows:

1634 65-1-189. There is created in the State Treasury a special  
1635 fund to be designated as the "2023 Gulfport Commerce Corridor  
1636 Fund," which shall consist of funds made available by the  
1637 Legislature in any manner and funds from any other source  
1638 designated for deposit into such fund. The fund shall be  
1639 maintained by the State Treasurer as a separate and special fund,  
1640 separate and apart from the General Fund of the state. Monies  
1641 deposited into the fund shall be used \* \* \*, upon appropriation by  
1642 the Legislature, \* \* \* by the Mississippi Department of  
1643 Transportation in paying the costs associated with the Gulfport  
1644 Commerce Corridor project located in the City of Gulfport.  
1645 Unexpended amounts remaining in the fund at the end of a fiscal
