SENATE BILL NO. 2862

AN ACT TO AMEND SECTION 45-14-31, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT THE STATE BOARD OF HEALTH MAY COLLECT LICENSING AND ADMINISTRATION FEES FOR CERTAIN RADIOLOGICAL HEALTH SERVICES IN CONGRUENCE WITH FEDERAL REGULATIONS; AND FOR RELATED PURPOSES.

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 45-14-31, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 45-14-31. (1) All initial application and registration fees
- 9 and annual fees due under this section shall be paid directly to
- 10 the agency for deposit into the Radiological Health Operations
- 11 Fund in the State Treasury. The Mississippi State Board of Health
- 12 shall submit its separate budget for carrying out the provisions
- 13 of this chapter. The budget shall be subject to and shall comply
- 14 with the requirements of the state budget law.
- 15 (2) In order to supplement state radiological health budget
- 16 allocations authorized to carry out and enforce the provisions of
- 17 this chapter, the agency is authorized to charge and collect fees
- 18 for the following radiological health services:

| 36 | SECTION 2. This act shall take effect and be in force from |
