SENATE BILL NO. 2962

1 AN ACT MAKING AN APPROPRIATION TO THE CITY OF BROOKHAVEN FOR  
2 THE PURPOSE OF DEFRAYING THE COSTS OF CERTAIN INFRASTRUCTURE  
3 PROJECTS FOR THE FISCAL YEAR 2025.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 **SECTION 1.** The following sum, or so much of it as may be  
6 necessary, is appropriated out of any money in the State General  
7 Fund not otherwise appropriated, to the City of Brookhaven for the  
8 purpose of defraying the costs of certain infrastructure projects  
9 for the fiscal year beginning July 1, 2024, and ending June 30,  
10 2025.....\$ 8,700,000.00.

11 **SECTION 2.** Of the funds appropriated under the provisions of  
12 Section 1 of this act, the following amounts are to be allocated  
13 as follows:

14 To defray costs of construction,  
15 design, resurfacing and  
16 widening of Brookway  
17 Boulevard.....\$ 4,000,000.00

18 To defray costs of improvements



19           to the wastewater treatment  
 20           plant.....\$ 1,000,000.00  
 21    To defray costs of extending  
 22           sewer service to unserved  
 23           residents of the  
 24           city.....\$ 1,000,000.00  
 25    To defray costs of city-wide  
 26           rehabilitation, improvement  
 27           and upgrade to the sewer  
 28           system.....\$ 1,000,000.00  
 29    To defray costs of renovating  
 30           and upgrading Brignall Well.....\$   500,000.00  
 31    To defray costs of closing the  
 32           existing Class I rubbish  
 33           pit and opening a new cell  
 34           for Class I rubbish disposal.....\$   750,000.00  
 35    To defray costs of construction  
 36           of and equipping a new  
 37           animal shelter.....\$   250,000.00  
 38    To defray costs of improvement to  
 39           the lagoon at the wastewater  
 40           treatment plant, including  
 41           the dredging of sludge and  
 42           installing of solar powered  
 43           algae eliminator.....\$   200,000.00



44           **SECTION 3.** The money appropriated by this act shall be paid  
45 by the State Treasurer out of any money in the State General Fund  
46 not otherwise appropriated, upon warrants issued by the State  
47 Fiscal Officer; and the State Fiscal Officer shall issue his or  
48 her warrants upon requisitions signed by the proper person,  
49 officer or officers in the manner provided by law.

50           **SECTION 4.** This act shall take effect and be in force from  
51 and after July 1, 2024.
