5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
6	SECTION 1. The following sum, or so much thereof as may be
7	necessary, is hereby appropriated out of any funds in the State
8	General Fund not otherwise appropriated, to the Board of Trustees
9	of State Institutions of Higher Learning to be used for the
10	operation of the College of Veterinary Medicine at Mississippi
11	State University, for the fiscal year beginning July 1, 2024, and
12	ending June 30, 2025\$ 20,659,580.00.
13	SECTION 2. The following sum, or so much thereof as may be
14	necessary, is hereby authorized for expenditure out of any special
15	source funds which are collected by or otherwise become available
16	for the purpose of defraying the expenses of the College of
17	Veterinary Medicine at Mississippi State University, for the
18	fiscal year beginning July 1, 2024, and ending June 30, 2025

21	act, Seven Hundred Fifty Thousand Dollars (\$750,000.00) shall be
22	derived from the Education Enhancement Fund from funds deposited
23	pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of
24	1972.
25	SECTION 4. No general funds authorized to be expended herein
26	shall be used to replace federal funds and/or other special funds
27	which are being used for salaries authorized under the provisions
28	of this act and which are withdrawn and no longer available.
29	SECTION 5. It is the intention of the Legislature that the
30	agency's budget request for Fiscal Year 2026 shall be submitted to
31	the Joint Legislative Budget Committee in a format and level of
32	detail comparable to the format and level of detail provided
33	during the Fiscal Year 2025 budget request process.
34	SECTION 6. In compliance with the "Mississippi Performance
35	Budget and Strategic Planning Act of 1994," it is the intent of
36	the Legislature that the funds provided herein shall be utilized
37	in the most efficient and effective manner possible to achieve the
38	intended mission of this agency. Based on the funding authorized,
39	this agency shall make every effort to attain the targeted
40	performance measures provided below:

30	SECTION 7. Of the funds appropriated in Section 1 of this
31	act, the amount of One Hundred Twenty-five Thousand Dollars
32	(\$125,000.00) shall be used for the purpose of testing,
3	programming, and personnel-related expenses for Chronic Waste
34	Disease.
35	SECTION 8. It is the intention of the Legislature that
36	whenever two (2) or more bids are received by this agency for the
37	purchase of commodities or equipment, and whenever all things
38	stated in such received bids are equal with respect to price,
39	quality and service, the Mississippi Industries for the Blind
90	shall be given preference. A similar preference shall be given to
91	the Mississippi Industries for the Blind whenever purchases are
92	made without competitive bids.
93	SECTION 9. It is the intention of the Legislature that the

funds herein appropriated shall be expended in compliance with

- 95 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 96 shall incur obligations or indebtedness in excess of their
- 97 appropriation and that the responsible officers, either personally
- 98 or upon their official bonds, shall be held responsible for
- 99 actions contrary to this provision.
- 100 **SECTION 10.** Of the funds appropriated in Section 1 of this
- 101 act, Sixty Thousand Dollars (\$60,000.00) is hereby provided for
- 102 scholarships for the Dr. Elton Mac Huddleston Rural Veterinarians
- 103 Scholarship Program as described in HB 1210, 2024 Regular Session.
- SECTION 11. Of the funds in Section 2 of this act, Eighteen
- 105 Million Dollars (\$18,000,000.00) is provided from the Mississippi
- 106 State University Veterinary School Fund as created in SB 2468,
- 107 2024 Regular Session.
- 108 **SECTION 12.** The money herein appropriated shall be paid by
- 109 the State Treasurer out of any money in the State Treasury to the
- 110 credit of the proper fund or funds as set forth in this act, upon
- 111 warrants issued by the State Fiscal Officer; and the State Fiscal
- 112 Officer shall issue his warrants upon requisitions signed by the
- 113 proper person, officer or officers in the manner provided by law.
- 114 **SECTION 13.** This act shall take effect and be in force from
- 115 and after July 1, 2024.
