3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
4	SECTION 1. The following sum, or so much thereof as may be
5	necessary, is hereby appropriated out of any money in the State
6	General Fund not otherwise appropriated, for the purpose of
7	defraying the expenses of the Mississippi Ethics Commission for
8	the fiscal year beginning July 1, 2024, and ending
9	June 30, 2025\$ 750,319.00.
10	SECTION 2. Of the funds appropriated under the provisions of
11	this act, the following positions are authorized:
12	AUTHORIZED HEADCOUNT:
13	Permanent: 6
14	Time-Limited: 0
15	Any transfers or escalations shall be made in accordance with
16	the terms, conditions and procedures established by law.
17	No general funds authorized to be expended herein shall be

- 19 being used for salaries authorized under the provisions of this
- 20 act and which are withdrawn and no longer available.
- 21 **SECTION 3.** It is the intention of the Legislature that the
- 22 Mississippi Ethics Commission shall maintain complete accounting
- 23 and personnel records related to the expenditure of all funds
- 24 appropriated under this act and that such records shall be in the
- 25 same format and level of detail as maintained for Fiscal Year
- 26 2024. It is further the intention of the Legislature that the
- 27 agency's budget request for Fiscal Year 2026 shall be submitted to
- 28 the Joint Legislative Budget Committee in a format and level of
- 29 detail comparable to the format and level of detail provided
- 30 during the Fiscal Year 2025 budget request process.
- 31 **SECTION 4.** It is the intention of the Legislature that
- 32 whenever two (2) or more bids are received by this agency for the
- 33 purchase of commodities or equipment, and whenever all things
- 34 stated in such received bids are equal with respect to price,
- 35 quality and service, the Mississippi Industries for the Blind
- 36 shall be given preference. A similar preference shall be given to
- 37 the Mississippi Industries for the Blind whenever purchases are
- 38 made without competitive bids.
- 39 **SECTION 5.** It is the intention of the Legislature, that of
- 40 the funds provided in Section 1 of this act, the Ethics Commission
- 41 is hereby authorized to purchase and pay premiums for casualty
- 42 insurance on passenger vehicles owned and operated by the agency.

13	SECTION 6. It is the intention of the Legislature that the
14	funds herein appropriated shall be expended in compliance with
15	Section 27-104-25, Mississippi Code of 1972, that no state agency
16	shall incur obligations or indebtedness in excess of their
17	appropriation and that the responsible officers, either personally
18	or upon their official bonds, shall be held responsible for
19	actions contrary to this provision.
50	SECTION 7. The money herein appropriated shall be paid by
51	the State Treasurer out of any money in the State Treasury to the
52	credit of the proper fund or funds as set forth in this act, upon
53	warrants issued by the State Fiscal Officer; and the State Fiscal
54	Officer shall issue his warrants upon requisitions signed by the
55	proper person, officer or officers, in the manner provided by law.
56	SECTION 8. This act shall take effect and be in force from

and after July 1, 2024.
