1 AN ACT MAKING AN APPROPRIATION OF SPECIAL FUNDS TO DEFRAY THE 2 EXPENSES OF THE STATE BOARD OF ARCHITECTURE AND LANDSCAPE 3 ARCHITECTURE ADVISORY COMMITTEE FOR FISCAL YEAR 2025. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. The following sum, or so much thereof as may be 6 necessary, is hereby appropriated out of any money in the State 7 Treasury to the credit of the State Board of Architecture and Landscape Architecture Advisory Committee, for the purpose of 8 9 defraying the expenses incurred by said board for the fiscal year beginning July 1, 2024, and ending June 30, 2025...... 10\$ 362,783.00. 11 SECTION 2. Of the funds appropriated under the provisions of 12 this act, the following positions are authorized: 13 14 AUTHORIZED HEADCOUNT: 15 Permanent: Time-Limited: 16 ()With the funds herein appropriated, it shall be the agency's 17 18 responsibility to make certain that funds required for Personal

- 19 Services for Fiscal Year 2026 do not exceed Fiscal Year 2025 funds
- 20 appropriated for that purpose unless programs or positions are
- 21 added to the agency's Fiscal Year 2025 budget by the Mississippi
- 22 Legislature. The Legislature shall determine the agency's
- 23 personal services appropriation, which the State Personnel Board
- 24 shall publish. The agency's personal services appropriation may
- 25 consist of restricted funds for approved vacancies for Fiscal Year
- 26 2025 that may be utilized to fill vacant Fiscal Year 2024
- 27 headcount. It shall be the agency's responsibility to ensure that
- 28 the funds provided for vacancies are used to increase headcount
- 29 and not for promotions, title changes, in-range salary adjustments
- 30 or any other mechanism for increasing salaries for current
- 31 employees. It is the Legislature's intention that no employee
- 32 salary falls below the minimum salary established by the
- 33 Mississippi State Personnel Board.
- 34 Additionally, the State Personnel Board shall determine and
- 35 publish the projected annualized payroll costs based on current
- 36 employees. It shall be the responsibility of the agency head to
- 37 ensure that actual personnel expenditures for Fiscal Year 2025 do
- 38 not exceed the data provided by the Legislative Budget Office. If
- 39 the agency's Fiscal Year 2025 projected cost exceeds the
- 40 annualized costs, no salary actions shall be processed by the
- 41 State Personnel Board except for new hires determined to be
- 42 essential for the agency.

43	Any transfers or escalations shall be made in accordance with
44	the terms, conditions, and procedures established by law or
45	allowable under the terms set forth within this act. The State
46	Personnel Board shall not escalate positions without written
47	approval from the Department of Finance and Administration. The
48	Department of Finance and Administration shall not provide writter
49	approval to escalate any funds for salaries and/or positions
50	without proof of availability of new or additional funds above the

- No general funds authorized to be expended herein shall be 52 53 used to replace federal funds and/or other special funds used for 54 salaries authorized under the provisions of this act and which are 55 withdrawn and no longer available.
- 56 None of the funds herein appropriated shall be used in 57 violation of the Internal Revenue Service's Publication 15-A 58 relating to the reporting of income paid to contract employees, as 59 interpreted by the Office of the State Auditor.
- 60 SECTION 3. It is the intention of the Legislature that the 61 Board of Architecture shall maintain complete accounting and 62 personnel records related to the expenditure of all funds appropriated under this act and that such records shall be in the 63 same format and level of detail as maintained for Fiscal Year 64 2024. It is further the intention of the Legislature that the 65 66 agency's budget request for Fiscal Year 2026 shall be submitted to the Joint Legislative Budget Committee in a format and level of 67

- 70 SECTION 4. It is the intention of the Legislature that
- 71 whenever two (2) or more bids are received by this agency for the
- 72 purchase of commodities or equipment, and whenever all things
- 73 stated in such received bids are equal with respect to price,
- 74 quality and service, the Mississippi Industries for the Blind
- 75 shall be given preference. A similar preference shall be given to
- 76 the Mississippi Industries for the Blind whenever purchases are
- 77 made without competitive bids.
- 78 SECTION 5. It is the intention of the Legislature that the
- 79 funds herein appropriated shall be expended in compliance with
- 80 Section 27-104-25, Mississippi Code of 1972, that no state agency
- shall incur obligations or indebtedness in excess of their 81
- 82 appropriation and that the responsible officers, either personally
- 83 or upon their official bonds, shall be held responsible for
- 84 actions contrary to this provision.
- 85 **SECTION 6.** The money herein appropriated shall be paid by
- 86 the State Treasurer out of any money in the State Treasury to the
- 87 credit of the proper fund or funds as set forth in this act, upon
- 88 warrants issued by the State Fiscal Officer; and the State Fiscal
- 89 Officer shall issue his warrants upon requisitions signed by the
- 90 proper person, officer or officers in the manner provided by law.
- 91 SECTION 7. This act shall take effect and be in force from
- 92 and after July 1, 2024.
