SENATE BILL NO. 3059

1 AN ACT TO PROVIDE AN ADDITIONAL APPROPRIATION OF CAPITAL
2 EXPENSE FUNDS, AND SPECIAL FUNDS TO DEFRAY THE EXPENSES OF THE
3 STATE BOARD OF COSMETOLOGY FOR FISCAL YEAR 2024; MISSISSIPPI STATE
4 BOARD OF DENTAL EXAMINERS FOR FISCAL YEAR 2024; MISSISSIPPI STATE
5 DEPARTMENT OF HEALTH FOR YEARS 2024 AND 2025; WIRELESS
6 COMMUNICATIONS COMMISSION FOR YEARS 2024 AND 2025; AND FOR RELATED
7 PURPOSES.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

9 **SECTION 1.** In addition to all other sums herein
10 appropriated, the following sum, or so much thereof as may be
11 necessary, is appropriated out of any money in the State Treasury,
12 to the credit of the State Board of Cosmetology, and allocated in
13 a manner as determined by the Treasurer's Office, to defray the
14 expenses of the State Board of Cosmetology for the period
15 beginning July 1, 2023, and ending June 30, 2024.....
16\$ 57,000.00.

17 This additional appropriation is for the purpose of defraying
18 agency operational expenditures.

19 **SECTION 2.** In addition to all other sums herein
20 appropriated, the following sum, or so much thereof as may be



21 necessary, is appropriated out of any money in the State Treasury,
22 to the credit of the Mississippi State Board of Dental Examiners,
23 and allocated in a manner as determined by the Treasurer's Office,
24 to defray the expenses of the Mississippi State Board of Dental
25 Examiners for the period beginning July 1, 2023, and ending
26 June 30, 2024.....\$ 255,000.00.

27 This additional appropriation is for the purpose of agency
28 operational expenditures.

29 **SECTION 3.** In addition to all other sums herein
30 appropriated, the following sum, or so much thereof as may be
31 necessary, is appropriated out of any money to the credit of the
32 Capital Expense Fund, and allocated in a manner as determined by
33 the Treasurer's Office, to defray the expenses of the Mississippi
34 State Department of Health for the period beginning January 1,
35 2024, and ending December 31, 2024.....\$ 2,772,010.00.

36 This additional appropriation is for the purpose of defraying
37 legal expenses associated with the City of Jackson Water
38 litigation.

39 **SECTION 4.** In addition to all other sums herein
40 appropriated, the following sum, or so much thereof as may be
41 necessary, is appropriated out of any money in the State Treasury,
42 to the credit of the Wireless Communication Commission, and
43 allocated in a manner as determined by the Treasurer's Office, to
44 defray the expenses of the Wireless Communication Commission for
45 the period beginning upon passage of this act, and ending



46 June 30, 2025.....\$ 3,900,000.00.

47 This additional appropriation is for the purpose of paying
48 costs associated with adding new statewide communication towers in
49 needed locations pursuant to House Bill No. 603, 2023 Regular
50 Session.

51 **SECTION 5.** This act shall take effect and be in force from
52 and after July 1, 2023, and shall stand repealed from and after
53 June 30, 2023.
