Serving as the Clerk for the Lafayette County 35 Board of Supervisors, she helped the county achieve what they were setting out to achieve. "You could always call her, and you could 36 37 always count on her in any situation. Sherry's legacy is bigger 38 than Lafayette County," said Roberts; and 39 WHEREAS she leaves behind a community that is richer for her 40 selflessness, commitment and service.
