SENATE RESOLUTION NO. 112

1 A RESOLUTION COMMENDING AND CONGRATULATING CASEY WATTS OF  
2 LAUREL MAGNET SCHOOL OF ARTS IN LAUREL, MISSISSIPPI, FOR BEING  
3 NAMED AN "EXTRAORDINARY EDUCATOR FOR 2024" BY CURRICULUM
