The money appropriated by this act shall be paid 34 by the State Treasurer out of any money in the Capital Expense 35 Fund not otherwise appropriated, upon warrants issued by the State 36 Fiscal Officer; and the State Fiscal Officer shall issue his or 37 her warrants upon requisitions signed by the proper person, 38 officer or officers in the manner provided by law.

39 **SECTION 4.** This act shall take effect and be in force from 40 and after July 1, 2024, and shall stand repealed on June 30, 2024.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:
