## House Amendments to Senate Bill No. 2634

## TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

## AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 10 **SECTION 1.** (1) The segment of U.S. Highway 278 (Noah Curtis
- 11 Street) located in Shannon, Lee County, Mississippi, extending for
- 12 a distance of approximately one (1) mile in the westerly direction
- 13 from the eastern entrance of Shannon Primary School to a point
- 14 immediately west of the on-ramp interchange with U.S. Highway 45,
- 15 is designated and shall be known as the "Johnny R. Patterson
- 16 Memorial Highway."
- 17 (2) The Mississippi Department of Transportation shall erect
- 18 and maintain appropriate signs along and approaching the segment
- 19 of highway described in subsection (1) of this section.
- 20 <u>SECTION 2.</u> (1) The segment of Mississippi Highway 446
- 21 located in Bolivar County, Mississippi, extending for a distance
- 22 of approximately one (1) mile in the easterly direction from its
- 23 point of intersection with Shaw-Skene Road to its point of
- 24 intersection with Gilbert Road, is designated and shall be known
- 25 as the "H.M. "Mack" Grimmett Memorial Highway."

- 26 (2) The Mississippi Department of Transportation shall erect
- 27 and maintain appropriate signs along and approaching the segment
- 28 of highway described in subsection (1) of this section.
- 29 **SECTION 3.** (1) The segment of Mississippi Highway 28
- 30 located in Soso, Jones County, Mississippi, extending for a
- 31 distance of approximately one (1) mile in the northwesterly
- 32 direction beginning at its intersection with Margay Road to a
- 33 point of termination at its intersection with Mississippi Highway
- 34 29, is designated and shall be known as the "Paul Holifield
- 35 Memorial Highway."
- 36 (2) The Mississippi Department of Transportation shall erect
- 37 and maintain appropriate signs along and approaching the segment
- 38 of highway described in subsection (1) of this section.
- 39 **SECTION 4.** This act shall take effect and be in force from
- 40 and after July 1, 2024.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO DESIGNATE A SEGMENT OF <u>U.S. HIGHWAY 278 (NOAH</u> CURTIS STREET) LOCATED IN THE TOWN OF SHANNON, LEE COUNTY,

3 MISSISSIPPI, AS THE "JOHNNY R. PATTERSON MEMORIAL HIGHWAY"; TO

- DESIGNATE A SEGMENT OF MISSISSIPPI HIGHWAY 446 LOCATED IN BOLIVAR
- 5 COUNTY, MISSISSIPPI, AS THE "H.M. "MACK" GRIMMETT MEMORIAL
- 6 HIGHWAY"; TO DESIGNATE A SEGMENT OF MISSISSIPPI HIGHWAY 28 LOCATED
- 7 IN THE SOSO, JONES COUNTY, MISSISSIPPI, AS THE "PAUL HOLIFIELD
- 8 MEMORIAL HIGHWAY; AND FOR RELATED PURPOSES.
