

## House Amendments to Senate Bill No. 2801

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

### AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

6           **SECTION 1.** Section 27-19-56.549, Mississippi Code of 1972,  
7 is amended as follows:

8           27-19-56.549. (1) Any owner of a motor vehicle who is a  
9 resident of this state, upon payment of the road and bridge  
10 privilege taxes, ad valorem taxes and registration fees as  
11 prescribed by law for private carriers of passengers, pickup  
12 trucks and other noncommercial motor vehicles, and upon payment of  
13 an additional fee in the amount provided in subsection (4) of this  
14 section, shall be issued a distinctive license tag for any motor  
15 vehicle registered in his name identifying such person as a  
16 supporter of any one (1) of the following:

- 35 (r) Mississippi Road Builders Association;
- 36 (s) Clinton Public School District;
- 37 (t) Magnolia Speech School;
- 38 (u) Coahoma County Jr./Sr. High School;
- 39 (v) Clinton Community Nature Center;
- 40 (w) Most Worshipful King Hiram Grand Lodge & Electra
- 41 Grand Chapter Order of Eastern Star A.F. & A.M., State of
- 42 Mississippi;
- 43 (x) City of Olive Branch, Mississippi;
- 44 (y) Methodist Cursillo of Mississippi;
- 45 (z) Clarkdale High School in Lauderdale County,
- 46 Mississippi.

47 (2) The distinctive license tags so issued shall be of such

48 color and design as the Department of Revenue, with the advice of

49 the respective beneficiary organization listed in subsection (1)  
50 of this section, may prescribe and shall consist of such letters  
51 or numbers, or both, as may be necessary to distinguish each  
52 license tag.

53 (3) Application for the distinctive license tags authorized  
54 by this section shall be made to the county tax collector on forms  
55 prescribed by the Department of Revenue. The application and the  
56 additional fee imposed under subsection (4) of this section, less  
57 Two Dollars (\$2.00) thereof to be retained by the tax collector,  
58 shall be remitted to the Department of Revenue on a monthly basis  
59 as prescribed by the department. The portion of the additional  
60 fee retained by the tax collector shall be deposited into the  
61 county general fund.

62 (4) \* \* \* Any person applying for a distinctive license tag  
63 under this section shall pay an additional fee in the amount of  
64 Thirty Dollars (\$30.00) for each distinctive license tag applied  
65 for under this section, which shall be in addition to all other  
66 taxes and fees. The additional fee paid shall be for a period of  
67 time to run concurrently with the vehicle's established license  
68 tag year. The additional fee is due and payable at the time the  
69 original application is made for a distinctive license tag under  
70 this section and thereafter annually at the time of renewal  
71 registration as long as the owner retains the distinctive license  
72 tag. If the owner does not wish to retain the distinctive license  
73 tag, he must surrender it to the local county tax collector.

74           (5) The Department of Revenue shall deposit all fees into  
75 the State Treasury on the day collected. At the end of each  
76 month, the Department of Revenue shall certify to the State  
77 Treasurer the total fees collected under this section from the  
78 issuance of the distinctive license tags issued under this  
79 section. The State Treasurer shall distribute such collections as  
80 follows:

81           (a) Twenty-four Dollars (\$24.00) of each additional fee  
82 collected on distinctive license tags issued pursuant to this  
83 section shall be distributed to the appropriate beneficiary  
84 organization listed in subsection (1) of this section.

85           (b) One Dollar (\$1.00) of each additional fee collected  
86 on distinctive license tags issued pursuant to this section shall  
87 be deposited into the Mississippi Burn Care Fund created pursuant  
88 to Section 7-9-70.

89           (c) Two Dollars (\$2.00) of each additional fee  
90 collected on distinctive license tags issued pursuant to this  
91 section shall be deposited to the credit of the State Highway Fund  
92 to be expended solely for the repair, maintenance, construction or  
93 reconstruction of highways.

94           (d) One Dollar (\$1.00) of each additional fee collected  
95 on distinctive license tags issued pursuant to this section shall  
96 be deposited to the credit of the special fund created in Section  
97 27-19-44.2.

98           (6) A regular license tag must be properly displayed as  
99 required by law until replaced by a distinctive license tag under

100 this section. The regular license tag must be surrendered to the  
101 tax collector upon issuance of the distinctive license tag under  
102 this section. The tax collector shall issue up to two (2) license  
103 decals for each distinctive license tag issued under this section,  
104 which will expire the same month and year as the regular license  
105 tag.

106 (7) In the case of loss or theft of a distinctive license  
107 tag issued under this section, the owner may make application and  
108 affidavit for a replacement distinctive license tag as provided by  
109 Section 27-19-37. The fee for a replacement distinctive license  
110 tag shall be Ten Dollars (\$10.00). The tax collector receiving  
111 such application and affidavit shall be entitled to retain and  
112 deposit into the county general fund five percent (5%) of the fee  
113 for such replacement license tag and the remainder shall be  
114 distributed in the same manner as funds from the sale of regular  
115 distinctive license tags issued under this section.

116 **SECTION 2.** This act shall take effect and be in force from  
117 and after July 1, 2024, and shall stand repealed on June 29, 2024.

**Further, amend by striking the title in its entirety and  
inserting in lieu thereof the following:**

1 AN ACT TO AMEND SECTION 27-19-56.549, MISSISSIPPI CODE OF  
2 1972, TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE  
3 LICENSE TAGS TO SUPPORTERS OF CLARKDALE HIGH SCHOOL IN LAUDERDALE  
4 COUNTY, MISSISSIPPI; AND FOR RELATED PURPOSES.
