

House Amendments to Senate Bill No. 3020

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

4 **SECTION 1.** The following sum of money, or so much thereof as
5 may be necessary, is appropriated out of any money in the State
6 General Fund not otherwise appropriated, to defray the expenses of
7 the Department of Public Safety for the fiscal year beginning
8 July 1, 2024, and ending June 30, 2025.....\$ 158,155,576.00.

9 **SECTION 2.** The following sum, or so much thereof as may be
10 necessary, is appropriated out of any money in the State Treasury
11 to the credit of the Department of Public Safety for the purpose
12 of defraying the expenses incurred in the operation of the various
13 divisions of the department for the fiscal year beginning
14 July 1, 2024, and ending June 30, 2025.....\$ 107,854,977.00.

15 **SECTION 3.** Of the funds appropriated under the provisions of
16 this act, the following positions are authorized:

17 AUTHORIZED HEADCOUNT:
18 Permanent: 1,693
19 Time-Limited: 78

20 With the funds herein appropriated, it shall be the agency's
21 responsibility to make certain that funds required for Personal
22 Services for Fiscal Year 2026 do not exceed Fiscal Year 2025 funds
23 appropriated for that purpose unless programs or positions are
24 added to the agency's Fiscal Year 2025 budget by the Mississippi
25 Legislature. The Legislature shall determine the agency's personal
26 services appropriation, which the State Personnel Board shall
27 publish. In accordance with applicable laws, if an agency
28 determines that its personal services amount is insufficient, the
29 agency must contact the State Personnel Board. Any adjustment to
30 the personal services amount must be approved by the State
31 Personnel Director and the State Fiscal Officer after consultation
32 with the Legislative Budget Office. Any adjustment shall be
33 reported to the Legislative Budget Office and the House and Senate
34 Appropriations Chairmen. The agency's personal services
35 appropriation may consist of restricted funds for approved
36 vacancies for Fiscal Year 2025 that may not be utilized for active
37 Fiscal Year 2024 headcount. It shall be the agency's
38 responsibility to ensure that the funds provided for vacancies are
39 used to increase headcount and not for promotions, title changes,
40 in-range salary adjustments, or any other mechanism for increasing
41 salaries for current employees. If the State Personnel Board
42 determines that an agency has used provided vacancy funds for any
43 of the mechanisms previously listed, the State Personnel Board
44 shall not process any additional salary actions for the agency in
45 the current fiscal year, except for new hires determined by the

46 State Personnel Board to be essential for the agency. It is the
47 Legislature's intention that no employee salary falls below the
48 minimum salary established by the Mississippi State Personnel
49 Board.

50 Additionally, the State Personnel Board shall determine and
51 publish the projected annualized payroll costs based on current
52 employees. It shall be the responsibility of the agency head to
53 ensure that actual personnel expenditures for Fiscal Year 2025 do
54 not exceed the data provided by the Legislative Budget Office. If
55 the agency's projected cost for Fiscal Year 2025 exceeds the
56 annualized costs, no salary actions shall be processed by the
57 State Personnel Board except for new hires determined to be
58 essential for the agency.

59 Any transfers or escalations shall be made in accordance with
60 the terms, conditions, and procedures established by law or
61 allowable under the terms set forth within this act. The State
62 Personnel Board shall not escalate positions without written
63 approval from the Department of Finance and Administration. The
64 Department of Finance and Administration shall not provide written
65 approval to escalate any funds for salaries and/or positions
66 without proof of availability of new or additional funds above the
67 appropriated level.

68 No general funds authorized to be expended herein shall be
69 used to replace federal funds and/or other special funds used for
70 salaries authorized under the provisions of this act and which are
71 withdrawn and no longer available.

72 None of the funds herein appropriated shall be used in
73 violation of the Internal Revenue Service's Publication 15-A
74 relating to the reporting of income paid to contract employees, as
75 interpreted by the Office of the State Auditor.

76 **SECTION 4.** The Commissioner of Public Safety may, on a
77 case-by-case basis, within funds available, recommend that
78 corrective salary adjustments be made to the compensation of
79 employees of the Department of Public Safety where an inequity was
80 created between employees of equivalent capacity by previous
81 application of the agency appropriation acts. Any such corrective
82 salary adjustment plan must have prior approval by the State
83 Personnel Board. Such adjustments will not be retroactive.

84 Any funds in the Salary, Wages and Fringe Benefits major
85 object of expenditure may be used to purchase accumulated
86 compensatory time within funds available.

87 **SECTION 5.** It is the intention of the Legislature, that the
88 Department of Public Safety shall receive Five Million Dollars
89 (\$5,000,000.00) from the Mississippi Department of Transportation,
90 for the operations of the Office of Commercial Transportation
91 Enforcement Division that is authorized in Section 77-7-330,
92 Mississippi Code of 1972.

93 **SECTION 6.** It is the intent of the Legislature that the
94 local governments pay for part of the computer cost of the
95 Mississippi Justice Information Center by maintaining their
96 contribution to the Department of Public Safety.

97 **SECTION 7.** It is the intention of the Legislature that the
98 Department of Public Safety designate certain employees to aid the
99 Office of Forensics Laboratories in the billing and collecting of
100 all fees charged for services rendered by the Office of Forensics
101 Laboratories.

102 **SECTION 8.** No part of the funds appropriated herein shall be
103 transferred to, expended by, or used, directly or indirectly, for
104 the benefit of any public relations, publicity or publication
105 activities of any other state agency, department or officer, nor
106 shall any personnel paid with funds appropriated herein be
107 transferred or assigned to any other state agency, department or
108 officer for public relations, publicity, or publication activities
109 of such office.

110 **SECTION 9.** It is the intention of the Legislature that the
111 Department of Public Safety shall not issue citations for
112 violations of speed limits on a quota basis. No funds expended
113 under this act shall be used for such quota-based citations for
114 violations of speed limits.

115 **SECTION 10.** In compliance with the "Mississippi Performance
116 Budget and Strategic Planning Act of 1994," it is the intent of
117 the Legislature that the funds provided herein shall be utilized
118 in the most efficient and effective manner possible to achieve the
119 intended mission of this agency. Based on the funding authorized,
120 this agency shall make every effort to attain the targeted
121 performance measures provided below:

279 A reporting of the degree to which the performance targets
280 set above have been or are being achieved shall be provided in the
281 agency's budget request submitted to the Joint Legislative Budget
282 Committee for Fiscal Year 2026.

283 **SECTION 11.** It is the intention of the Legislature that all
284 divisions within the Mississippi Department of Public Safety shall
285 maintain complete accounting and personnel records related to the
286 expenditure of all funds appropriated under this act and that such
287 records shall be in the same format and level of detail as
288 maintained for Fiscal Year 2024. It is further the intention of
289 the Legislature that the agency's budget request for Fiscal Year
290 2026 shall be submitted to the Joint Legislative Budget Committee
291 in a format and level of detail comparable to the format and level
292 of detail provided during the Fiscal Year 2025 budget request
293 process.

294 **SECTION 12.** Of the funds appropriated under the provisions
295 of Section 2 of this act, funds may be expended to defray the
296 costs of clothing for sworn nonuniform law enforcement officers in
297 an amount not to exceed One Thousand Dollars (\$1,000.00) annually
298 per officer.

299 **SECTION 13.** It is the intention of the Legislature that
300 whenever two (2) or more bids are received by this agency for the
301 purchase of commodities or equipment, and whenever all things
302 stated in such received bids are equal with respect to price,
303 quality and service, the Mississippi Industries for the Blind
304 shall be given preference. A similar preference shall be given to

305 the Mississippi Industries for the Blind whenever purchases are
306 made without competitive bids.

307 **SECTION 14.** The department is authorized to expend available
308 funds on technology or equipment upgrades or replacements when it
309 will generate savings through efficiency or when the savings
310 generated from such upgrades or replacements exceed expenditures
311 thereof.

312 **SECTION 15.** Of the funds provided herein, and in addition to
313 the One Hundred Dollars (\$100.00) authorized in Section 45-3-7,
314 Mississippi Code of 1972, Department of Public Safety Officers who
315 are licensed commercial pilots shall receive an additional Nine
316 Hundred Dollars (\$900.00), for a total of One Thousand Dollars
317 (\$1,000.00), additional compensation for such service.

318 **SECTION 16.** It is the direction of the Legislature that all
319 Fair Labor Standards Act (FLSA) nonexempt sworn officers of the
320 Mississippi Highway Safety Patrol who are working one hundred
321 seventy-one (171) hours in a twenty-eight-day work cycle be
322 compensated based on the annual salary established by the State
323 Personnel Board for a one-hundred-sixty-hour per month schedule
324 divided by two thousand eighty-seven and one hundred forty-three
325 one thousandths (2,087.143), for an hourly rate, to be multiplied
326 by two thousand two hundred twenty-three (2,223) or one hundred
327 seventy-one (171) hours in a twenty-eight-day work cycle for a new
328 annual salary. All hours worked over one hundred seventy-one
329 (171) hours in a twenty-eight-day schedule shall be governed by
330 the FLSA or other special compensation plan. All realignments

331 after July 1, 2010, shall be calculated using this formula. This
332 section shall be known as the "David R. Huggins Act."

333 **SECTION 17.** Of the funds appropriated in Sections 1 and 2 of
334 this act, Four Hundred Ninety-five Thousand One Hundred Ninety
335 Dollars (\$495,190.00) is appropriated out of any funds in the
336 State Treasury to the credit of the Department of Public Safety
337 for the purposes of paying for eleven (11) hours of compensatory
338 time at an hourly rate based on two thousand eighty-seven and one
339 hundred forty-three one thousandths (2,087.143) hours per year for
340 sworn officers who hold the rank of Lieutenant and above. The
341 funds provided in this section to pay for the eleven (11) hours
342 authorized in this section shall be expended only for this
343 purpose.

344 **SECTION 18.** It is the intention of the Legislature that the
345 Department of Public Safety shall provide an annual report to the
346 Mississippi Legislature detailing any elected official or any
347 other person who is not an employee of the Department of Public
348 Safety who was transported in Highway Patrol aircraft during the
349 fiscal year. The report shall be provided to each member of the
350 Mississippi Legislature on or before January 15, 2025.

351 **SECTION 19.** The Commissioner of Public Safety shall have the
352 authority to transfer any funds from any division within the
353 Department of Public Safety to any other division of the
354 Department of Public Safety Special Funds, including, but not
355 limited to, Funds 3711, 371C, 371E, 3713, 3714, 3715, 3740, 3741,
356 3742, 3744, 3747 and 3718, not to exceed Twenty Million Dollars

357 (\$20,000,000.00) collectively during Fiscal Year 2025. However,
358 none of the funds appropriated by this act shall be expended
359 unless the Department of Public Safety provides prior written
360 notification of any transfer of funds provided in this section.

361 **SECTION 20.** The Bureau of Narcotics is authorized to expend
362 a sum, not to exceed Five Hundred Thousand Dollars (\$500,000.00)
363 from account No. 3371800000, for purposes of effectuating the
364 provisions of Section 41-29-179, Mississippi Code of 1972, Section
365 1 of this act. Expenditures authorized by this section may
366 include, but not be limited to, costs associated with contracting
367 with one or more vendors, contractors or other persons or entities
368 to create, operate and maintain the forfeiture website and to
369 provide continuing support in relation thereto. In the event an
370 amount less than Five Hundred Thousand (\$500,000.00) is required
371 to effectuate the purposes of this section, the Bureau is
372 authorized to expend the remainder of such authorized funds for
373 the purchase of commodities, vehicles and/or other equipment
374 necessary in the furtherance of the needs of the Bureau.

375 **SECTION 21.** Of the funds appropriated in Section 1 of this
376 act, it is the intention of the Legislature that Four Million
377 Three Hundred Twelve Thousand Six Hundred Two Dollars
378 (\$4,312,602.00) may be allocated for the programs supported from
379 General Fund court assessments as follows:

394 **SECTION 22.** It is the intention of the Legislature that the
395 Mississippi Bureau of Narcotics, Mississippi Department of Public
396 Safety, shall have the authority to receive, budget and expend
397 special funds from the Drug Evidence Disposition Funds
398 (3372000000), not to exceed Five Hundred Thousand Dollars
399 (\$500,000.00).

400 **SECTION 23.** Of the funds appropriated by this act, pursuant
401 to Section 97-3-54.9, Mississippi Code of 1972, Two Hundred Fifty
402 Thousand Dollars (\$250,000.00) is provided for the duties and
403 operations of a Statewide Human Trafficking Coordinator and a data
404 analyst within the Bureau of Investigation in the Department of
405 Public Safety, who shall coordinate all statewide activities and
406 work with the Department of Child Protection Services for all
407 victims recovered.

408 **SECTION 24.** Of the funds appropriated by this act, pursuant
409 to Section 45-1-2(7), Mississippi Code of 1972, Two Hundred
410 Forty-two Thousand Six Hundred Three Dollars (\$242,603.00) is
411 provided for the duties and operations associated with the
412 Mississippi School Safety Act of 2019.

413 **SECTION 25.** The following sum, or so much thereof as may be
414 necessary, is reappropriated out of any money in the Capital
415 Expense Fund not otherwise appropriated to the Department of
416 Public Safety for the purpose of reauthorizing the expenditure of
417 Capital Expense Funds, as authorized in Senate Bill No. 3012, 2023
418 Regular Session, to the Department of Public Safety for the fiscal
419 year beginning July 1, 2024, and ending
420 June 30, 2025.....\$ 6,208,815.00.

421 This reappropriation is for the following purposes:

- 422 (a) Forensics Case Backlog.....\$ 432,815.00.
423 (b) Driver Services Bureau IDEMIA System...\$ 5,610,000.00.
424 (c) Driver Services Bureau to upgrade and maintain the
425 IDEMIA System and any equipment necessary to implement
426 requirements under Section 63-1-16, Mississippi Code of 1972.....
427\$ 166,000.00.

428 Notwithstanding the amount reappropriated under this section,
429 the amount that may be expended under the authority of this
430 section shall not exceed the unexpended balance of the funds
431 remaining as of June 30, 2024, from the amount authorized for the
432 previous fiscal year. In addition, this reappropriation shall not
433 change the purpose for which the funds were originally authorized.

434 **SECTION 26.** The department may subgrant a portion of the
435 funds appropriated herein to the Jackson Police Department for
436 eligible activities contingent upon the execution of an
437 operational agreement between the Capitol Police and Jackson
438 Police Department on roles and responsibilities within the Capitol
439 Complex Improvement District.

440 **SECTION 27.** With the funds appropriated herein, the
441 Department of Public Safety is authorized to make payment to
442 certain vendors for expenses incurred during Fiscal Years 2017
443 through 2023 in the following total amount.....\$ 21,172.67.

444 **SECTION 28.** The money herein appropriated shall be paid by
445 the State Treasurer out of any money in the State Treasury to the
446 credit of the proper fund or funds as set forth in this act, upon
447 warrants issued by the State Fiscal Officer; and the State Fiscal
448 Officer shall issue his warrants upon requisitions signed by the
449 proper person, officer or officers, in the manner provided by law.

450 **SECTION 29.** This act shall take effect and be in force from
451 and after July 1, 2024, and shall stand repealed from and after
452 June 29, 2024.
