

House Amendments to Senate Bill No. 3059

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

9 **SECTION 1.** In addition to all other sums herein
10 appropriated, the following sum, or so much thereof as may be
11 necessary, is appropriated out of any money in the State Treasury
12 to the credit of the Mississippi State Board of Dental Examiners
13 and allocated in a manner as determined by the Treasurer's Office,
14 to defray the expenses of the Mississippi State Board of Dental
15 Examiners for the period beginning upon passage, and ending June
16 30, 2025.....\$ 320,000.00.

17 This additional appropriation is for the purpose of defraying
18 the costs of relocating the agency, facility inspections, and
19 replacing the agency's database system.

20 **SECTION 2.** In addition to all other sums herein
21 appropriated, the following sum, or so much thereof as may be
22 necessary, is appropriated out of any money to the credit of the
23 Capital Expense Fund, and allocated in a manner as determined by
24 the Treasurer's Office, to defray the expenses of the Mississippi

25 Emergency Management Agency for the period beginning July 1, 2023,
26 and ending June 30, 2024.....\$ 1,575,864.00.

27 This additional appropriation is for the purpose of
28 reimbursing the Disaster Trust Fund for expenditures incurred for
29 the 2023 Wildfire Coordination Mission.

30 **SECTION 3.** In addition to all other sums herein
31 appropriated, the following sum, or so much thereof as may be
32 necessary, is appropriated out of any money in the State Treasury
33 to the credit of the Mississippi Development Authority and
34 allocated in a manner as determined by the Treasurer's Office, to
35 defray the expenses of the Mississippi Development Authority for
36 the period beginning July 1, 2023, and ending June 30, 2024.....
37\$ 5,000,000.00.

38 This additional appropriation is for the purpose of defraying
39 the cost of the Forestry Facility Grant Program established in
40 Section 57-1-781, Mississippi Code of 1972.

41 **SECTION 4.** In addition to all other sums herein
42 appropriated, the following sum, or so much thereof as may be
43 necessary, is appropriated out of any money to the credit of the
44 Capital Expense Fund, and allocated in a manner as determined by
45 the Treasurer's Office, to defray the expenses of the Office of
46 the Secretary of State for the period upon passage, and ending
47 June 30, 2025.....\$ 3,977,000.00.

48 This additional appropriation is for the purpose of defraying
49 the expenses of software system updates and upgrades.

50 **SECTION 5.** In addition to all other sums herein appropriated,
51 the following sum, or so much thereof as may be necessary, is
52 appropriated out of any money in the State Treasury to the credit
53 of the Mississippi Wireless Communication Commission and allocated
54 in a manner as determined by the Treasurer's Office, to defray the
55 expenses of the Mississippi Wireless Communication Commission for
56 the period beginning upon passage, and ending June 30, 2025.....
57\$ 3,900,000.00.

58 This additional appropriation is for the purpose of defraying
59 the cost associated with adding new statewide communication
60 towers.

61 **SECTION 6.** In addition to all other sums herein
62 appropriated, the following sum, or so much thereof as may be
63 necessary, is appropriated out of any money to the credit of the
64 Capital Expense Fund and allocated in a manner as determined by
65 the Treasurer's Office to defray the expenses of the Mississippi
66 State Department of Health for the period beginning January 1,
67 2024, and ending December 31, 2024.....\$ 2,772,010.00.

68 This additional appropriation is provided for defraying the
69 costs of legal expenses associated with the City of Jackson's
70 water litigation.

71 **SECTION 7.** This act shall take effect and be in force from
72 and after its passage.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**

1 AN ACT MAKING AN ADDITIONAL APPROPRIATION OF CAPITAL EXPENSE
2 FUNDS AND SPECIAL FUNDS FOR FISCAL YEARS 2024 AND 2025 TO DEFRAY
3 THE EXPENSES OF THE MISSISSIPPI STATE BOARD OF DENTAL EXAMINERS;
4 THE MISSISSIPPI EMERGENCY MANAGEMENT AGENCY; THE MISSISSIPPI
5 DEVELOPMENT AUTHORITY; THE OFFICE OF THE SECRETARY OF STATE; THE
6 MISSISSIPPI WIRELESS COMMUNICATION COMMISSION; AND THE MISSISSIPPI
7 STATE DEPARTMENT OF HEALTH; AND FOR RELATED PURPOSES.
