1 AMEND after line 226 by inserting the following and 2 renumbering the succeeding section: 3 " SECTION 9. Section 97-5-31, Mississippi Code of 1972, is amended as follows: 4 5 97-5-31. As used in Sections 97-5-33 through 97-5-37, the following words and phrases shall have the meanings given to them 6 7 in this section: (a) "Child" means any individual who has not attained 8 9 the age of eighteen (18) years and is an identifiable child. 10 "Sexually explicit conduct" means actual, morphed (b) 11 or simulated:

12 (i) Oral genital contact, oral anal contact, or 13 sexual intercourse as defined in Section 97-3-65, whether between persons of the same or opposite sex; 14 15 (ii) Bestiality; 16 (iii) Masturbation; 17 (iv) Sadistic or masochistic abuse: Lascivious exhibition of the genitals or pubic 18 (V) 19 area of any person; or 20 (vi) Fondling or other erotic touching of the 21 genitals, pubic area, buttocks, anus or breast. 22 "Producing" means producing, directing, (C) manufacturing, issuing, publishing, morphing or advertising. 23 "Visual depiction" includes, without limitation, 24 (d) 25 developed or undeveloped film and video tape or other visual unaltered, altered or morphed reproductions by computer and 26 27 technology. 28 "Computer" has the meaning given in Title 18, (e) United States Code, Section 1030. 29 30 (f) "Morphed image" means any visual depiction or 31 representation, including any photograph, film, video, picture, or 32 computer or computer-generated image or picture, whether made or produced by electronic, mechanical, simulated or other means, of 33 sexually explicit conduct, where such visual depiction or 34 35 representation has been created, adapted, or modified to appear an 36 identifiable minor is engaging in sexual conduct or sexually

37 <u>explicit activity to appearing in a state of sexually explicit</u> 38 nudity.

39 (\* \* \*g) "Simulated" means any depicting of the 40 genitals or rectal areas that gives the appearance of sexual 41 conduct or incipient sexual conduct.

42 (h) "Identifiable child" means a child who was a minor 43 at the time the image was created, adapted, or modified or whose 44 image as a child was used in the creating, adapting or modifying 45 of the image; and is recognizable as an actual child by the 46 child's face, likeness, or other distinguishing characteristic, such as a unique birthmark or other recognizable feature. 47 The provisions of this paragraph (g) shall not be construed to require 48 49 proof of the actual identity of the identifiable child."
