29 deleting "and nine (9) nine-liter cases of distilled spirits"

47 website are eligible for sale at a package retailer and also
48 through direct shipment by a direct shipper"

51 this subsection shall not be subject to disclosure under the
52 Mississippi Public Records Act of 1983."
