

Senate Amendments to House Bill No. 1816

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

393 the United States Department of the Treasury in conformity
394 therewith at various state agencies and institutions, as
395 authorized in SB No. 3052, 2023 Regular Session, SB No. 3014, 2022
396 Regular Session, SB No. 3018, 2022 Regular Session, for the fiscal
397 year beginning July 1, 2024, and ending June 30, 2025.....

399 This reappropriation is made for the purpose of reauthorizing
400 the expenditure of Special Funds for construction, repair and
401 renovation projects, and any other eligible expenses in connection

403 Section 9901 of the American Rescue Plan Act of 2021 (ARPA) or any
404 guidance or regulation issued by the United States Department of
405 the Treasury in conformity therewith at the Department of Public
406 Safety and the Mississippi Emergency Management Agency that had
407 been authorized by the Legislature in prior fiscal years.

408 Notwithstanding the amount reappropriated under this section,
409 the amount that may be expended under the authority of this

414 **SECTION 21.** The Bureau of Building, Grounds and Real
415 Property Management of the Office of General Services is expressly
416 authorized and empowered to receive, budget and expend any state,
417 local or other source funds designated for supplemental funding of
418 construction and/or repair and renovation projects.

419 **SECTION 22.** The money herein appropriated shall be paid by
420 the State Treasurer out of any money in the State Treasury to the
421 credit of the proper fund or funds as set forth in this act, upon
422 warrants issued by the State Fiscal Officer; and the State Fiscal
423 Officer shall issue his warrants upon requisitions signed by the
424 proper person, officer or officers, in the manner provided by law.

425 **SECTION 23.** This act shall take effect and be in force from
426 and after July 1, 2024.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**

1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE
2 AND ADMINISTRATION TO REAUTHORIZE THE EXPENDITURE OF CAPITAL
