- 13 an additional fee in the amount provided in subsection (4) of this
- 14 section, shall be issued a distinctive license tag for any motor

- 45 (2) The distinctive license tags so issued shall be of such
- 46 color and design as the Department of Revenue, with the advice of
- 47 the respective beneficiary organization listed in subsection (1)
- 48 of this section, may prescribe and shall consist of such letters
- 49 or numbers, or both, as may be necessary to distinguish each
- 50 license tag.
- 51 (3) Application for the distinctive license tags authorized
- 52 by this section shall be made to the county tax collector on forms
- 53 prescribed by the Department of Revenue. The application and the
- 54 additional fee imposed under subsection (4) of this section, less
- 55 Two Dollars (\$2.00) thereof to be retained by the tax collector,
- 56 shall be remitted to the Department of Revenue on a monthly basis
- 57 as prescribed by the department. The portion of the additional
- 58 fee retained by the tax collector shall be deposited into the
- 59 county general fund.
- 60 (4) Beginning with any registration year commencing on or
- 61 after July 1, 2022, any person applying for a distinctive license
- 62 tag under this section shall pay an additional fee in the amount
- 63 of Thirty Dollars (\$30.00) for each distinctive license tag
- 64 applied for under this section, which shall be in addition to all

- 65 other taxes and fees. The additional fee paid shall be for a
- 66 period of time to run concurrently with the vehicle's established
- 67 license tag year. The additional fee is due and payable at the
- 68 time the original application is made for a distinctive license
- 69 tag under this section and thereafter annually at the time of
- 70 renewal registration as long as the owner retains the distinctive
- 71 license tag. If the owner does not wish to retain the distinctive
- 72 license tag, he must surrender it to the local county tax
- 73 collector.
- 74 (5) The Department of Revenue shall deposit all fees into
- 75 the State Treasury on the day collected. At the end of each
- 76 month, the Department of Revenue shall certify to the State
- 77 Treasurer the total fees collected under this section from the
- 78 issuance of the distinctive license tags issued under this
- 79 section. The State Treasurer shall distribute such collections as
- 80 follows:
- 81 (a) Twenty-four Dollars (\$24.00) of each additional fee
- 82 collected on distinctive license tags issued pursuant to this
- 83 section shall be distributed to the appropriate beneficiary
- 84 organization listed in subsection (1) of this section.
- 85 (b) One Dollar (\$1.00) of each additional fee collected
- 86 on distinctive license tags issued pursuant to this section shall
- 87 be deposited into the Mississippi Burn Care Fund created pursuant
- 88 to Section 7-9-70.



- 89 (c) Two Dollars (\$2.00) of each additional fee 90 collected on distinctive license tags issued pursuant to this 91 section shall be deposited to the credit of the State Highway Fund 92 to be expended solely for the repair, maintenance, construction or 93 reconstruction of highways.
- 94 (d) One Dollar (\$1.00) of each additional fee collected 95 on distinctive license tags issued pursuant to this section shall 96 be deposited to the credit of the special fund created in Section 97 27-19-44.2.
- 98 (6) A regular license tag must be properly displayed as 99 required by law until replaced by a distinctive license tag under 100 The regular license tag must be surrendered to the this section. 101 tax collector upon issuance of the distinctive license tag under 102 The tax collector shall issue up to two (2) license this section. 103 decals for each distinctive license tag issued under this section, 104 which will expire the same month and year as the regular license 105 tag.
- 106 In the case of loss or theft of a distinctive license 107 tag issued under this section, the owner may make application and 108 affidavit for a replacement distinctive license tag as provided by 109 Section 27-19-37. The fee for a replacement distinctive license tag shall be Ten Dollars (\$10.00). The tax collector receiving 110 such application and affidavit shall be entitled to retain and 111 112 deposit into the county general fund five percent (5%) of the fee for such replacement license tag and the remainder shall be 113

- 114 distributed in the same manner as funds from the sale of regular
- 115 distinctive license tags issued under this section.
- 116 **SECTION 2.** This act shall take effect and be in force from
- and after July 1, 2024, and shall stand repealed on June 30, 2024.
