## HOUSE BILL NO. 336

1 AN ACT MAKING AN APPROPRIATION TO THE STATE DEPARTMENT OF 2 HEALTH FOR THE PURPOSE OF PROVIDING FUNDS TO THE MAGNET COMMUNITY 3 HEALTH DISPARITY PROGRAM TO BE USED TO ADDRESS THE 4 DISPROPORTIONATE IMPACT ON THE MINORITY COMMUNITY OF CORONAVIRUS 5 INFECTIONS AND DEATHS FROM COVID-19, FOR THE FISCAL YEAR 2026. 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. The following sum, or so much of it as may be 8 necessary, is appropriated out of any money in the State General 9 Fund not otherwise appropriated, to the State Department of Health 10 for the purpose of providing funds to the MAGnet Community Health Disparity Program, whose mission is to strengthen collaboration 11 12 and coordination for improved health access, performance, outcomes and cost efficiencies and whose vision is to improve the health 13 14 status for all Mississippians through integrated health, which 15 shall be used for the purposes described in Section 2 of this act, for the fiscal year beginning July 1, 2025, and ending June 30, 16 2026.....\$ 11,000,000.00. 17 SECTION 2. (1) The money appropriated by Section 1 of this 18 19 act shall be used by the MAGnet Community Health Disparity Program

- 20 to address the disproportionate impact on the minority community
- 21 of coronavirus infections and deaths from COVID-19 by: (a)
- 22 developing and implementing plans to reduce and mitigate those
- 23 occurrences and negative outcomes from COVID-19 in the minority
- 24 community; and (b) taking actions to reduce the racial disparities
- 25 in the distribution and availability of the COVID-19 vaccines and
- 26 actions to reach out to the minority community to encourage
- 27 persons to get the vaccines.
- 28 (2) Federally Qualified Health Centers in the state are
- 29 eligible to receive funding through the MAGnet Community Health
- 30 Disparity Program from the funds appropriated by this act upon
- 31 application submitted to the MAGnet Community Health Corporation
- 32 for approval.
- 33 **SECTION 3.** The money appropriated by this act shall be paid
- 34 by the State Treasurer out of any money in the State General Fund
- 35 not otherwise appropriated, upon warrants issued by the State
- 36 Fiscal Officer; and the State Fiscal Officer shall issue his or
- 37 her warrants upon requisitions signed by the proper person,
- 38 officer or officers in the manner provided by law.
- 39 **SECTION 4.** This act shall take effect and be in force from
- 40 and after July 1, 2025.
