HOUSE BILL NO. 574

AN ACT TO ESTABLISH THE MISSISSIPPI COMMUNITY SCHOOLS GRANT PROGRAM FOR THE PURPOSE OF ALLOWING SCHOOLS OR SCHOOL DISTRICTS ESTABLISHED AS A DISTRICT OF INNOVATION TO CREATE COMMUNITY SCHOOLS; TO PROVIDE THAT THE STATE DEPARTMENT OF EDUCATION SHALL 5 ADMINISTER THE PROGRAM; TO PROVIDE THAT THE FUNDS SHALL BE DISTRIBUTED TO EACH DISTRICT OF INNOVATION APPROVED BY THE STATE 7 BOARD OF EDUCATION; TO PROVIDE CERTAIN DISTRIBUTION FORMULAS FOR 8 ALLOCATING THE FUNDS APPROPRIATED FOR THE GRANT PROGRAM; TO AMEND 9 SECTIONS 37-179-1 AND 37-179-3, MISSISSIPPI CODE OF 1972, TO 10 AUTHORIZE THE STATE BOARD OF EDUCATION TO APPROVE THE CREATION OF 11 DISTRICTS OF INNOVATION; TO DEFINE CERTAIN TERMS RELATED TO 12 "DISTRICTS OF INNOVATION"; TO LIMIT THE INITIAL APPROVAL AND SUBSEQUENT RENEWALS OF DISTRICTS OF INNOVATION TO FIVE-YEAR PERIODS; TO DIRECT THE BOARD TO PROMULGATE ADMINISTRATIVE RULES 14 15 AND REGULATIONS TO PRESCRIBE THE CONDITIONS AND PROCEDURES TO BE 16 USED BY LOCAL SCHOOL BOARDS TO BE APPROVED AS A DISTRICT OF 17 INNOVATION; TO SPECIFY THE CRITERIA TO BE ADDRESSED BY THE 18 ADMINISTRATIVE REGULATIONS; TO PRESCRIBE THE REQUIREMENTS FOR A 19 DISTRICT TO BE A DISTRICT OF INNOVATION APPLICANT; TO PRESCRIBE 20 THE STATUTORY REQUIREMENTS WITH WHICH SCHOOLS OF INNOVATION WITHIN 21 DISTRICTS OF INNOVATION MUST COMPLY; TO IDENTIFY AREAS IN WHICH 22 DISTRICTS OF INNOVATION MAY REQUEST APPROVAL OF PRACTICES THAT ARE 23 DIFFERENT THAN CURRENT STATUTORY REQUIREMENTS; AND FOR RELATED 24 PURPOSES.

- 25 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 26 **SECTION 1.** (1) There is established the Mississippi
- 27 Community Schools Grant Program which shall be administered by the
- 28 State Department of Education.

29	(2) In order to assist districts of innovation in the
30	creation of community schools, as established under the provisions
31	of Sections 37-179-1 and 37-179-3, funds from the program shall be
32	distributed, upon appropriation by the Legislature, to each
33	district of innovation approved by the State Board of Education
34	which desires to expand in innovation practices by developing
35	community schools.

- 36 (3) The department shall distribute grants to each eligible 37 district of innovation in the minimum amount of Two Hundred 38 Thousand Dollars (\$200,000.00). A district of innovation may be 39 awarded additional grant funds as follows:
- 40 (a) Ten percent (10%) of the annual base student cost
 41 under the adequate education fund for each student enrolled in the
 42 community school program, according to total district enrollment
 43 data submitted to the department by the local school district;
- 44 (b) Fifty Thousand Dollars (\$50,000.00) shall be
 45 allocated to a district of innovation located within a local
 46 school district with an identified student percentage of
 47 twenty-five (25%) of all students enrolled in the districts during
 48 the prior school year having received free lunch under the
 49 National School Lunch Program and School Breakfast Program; and
- National School Lunch Program and School Breakfast Program; and

 (c) In addition to the funds distributed in paragraphs

 (a) and (b) of this subsection, any remaining funds appropriated

 for the purposes of this grant program shall be distributed to

 districts of innovation receiving funds in paragraphs (a) and (b)

- 54 of this subsection on a pro rata amount by dividing the total
- 55 amount of the remaining funds by the total number of students
- 56 enrolled in all districts of innovation in the state, regardless
- 57 as to whether such district of innovation has developed a
- 58 community schools component.
- 59 (4) The department shall adopt such reasonable rules as
- 60 necessary for the administration of the program, but shall not
- 61 place additional qualification requirements on school districts
- 62 other than the minimum requirements in this section.
- 63 **SECTION 2.** Section 37-179-1, Mississippi Code of 1972, is
- 64 amended as follows:
- 65 37-179-1. (1) For purposes of this chapter, the following
- 66 terms shall have the meaning ascribed herein, unless the context
- 67 clearly indicates otherwise:
- 68 (a) "District of innovation" means a district that has
- 69 developed a plan of innovation in compliance with this section and
- 70 has been approved by the State Board of Education to be exempted
- 71 from certain administrative regulations and statutory provisions
- 72 to improve the educational performance of students within the
- 73 district;
- 74 (b) "Innovation" means a new or creative alternative to
- 75 existing instructional and administrative practices intended to
- 76 improve student learning and student performance of all students,
- 77 <u>including community schools;</u>

78	(c) "School of innovation" means a school that
79	voluntarily participates in a district of innovation plan to
80	improve instruction, including waivers and exemptions from local
81	school board policies, selected provisions of rules and
82	regulations promulgated by the State Board of Education, and
83	selected sections of the Mississippi Code of 1972, as permitted
84	under this section and Section 37-179-3;
85	(d) "Board" means the State Board of Education;
86	(e) "Department" means the State Department of
87	Education.
88	(f) "Community school" means a traditional district
89	public school that partners with community-based organizations to
90	coordinate academic, social, physical health and mental health
91	services, to reduce barriers to learning and improve education
92	outcomes. Community schools include all five (5) of the
93	<pre>following:</pre>
94	(i) Integrated student supports coordinated by a
95	community school director, which may include, but are not limited
96	to:
97	1. Medical, dental, vision care and mental
98	health services; or
99	2. Counselors to assist with housing,
100	transportation, nutrition, or criminal justice issues;
101	(ii) Expanded and enriched learning time and
102	opportunities including before school, after school, weekend and

103	summer programs, which provide additional academic instruction,
104	individualized academic support, enrichment activities, and
105	learning opportunities that emphasize real-world learning and
106	community problem solving, and which may include, but are not
107	<pre>limited to:</pre>
108	1. Art, music, drama and creative writing;
109	2. Hands-on experience with engineering or
110	science;
111	3. Tutoring and homework help; and
112	4. Recreational programs that enhance and are
113	<pre>consistent with the school's curriculum;</pre>
114	(iii) Active family and community engagement which
115	brings students' families and the community into the school as
116	partners in children's education and makes the school a
117	neighborhood hub, providing adults with educational opportunities
118	they want, including, but not limited to:
119	1. English as a second language class;
120	2. Citizenship preparation;
121	3. Computer skills;
122	4. Art;
123	5. GED classes; or
124	6. Other programs that bring community
125	members into the building for meetings or events;
126	(iv) Include, as a meaningful part of its
127	curriculum, a Science, Technology, Engineering and Mathematics

128	(STEM) program component commensurate and appropriate to the grade
129	level of the school; and
130	(v) Collaborative leadership and practices, which
131	build a culture of professional learning, collective trust, and
132	shared responsibility using strategies which shall, at a minimum,
133	<pre>include:</pre>
134	1. A school-based leadership team;
135	2. A community school director; and
136	3. A community-wide leadership team, which
137	may include, but not limited to:
138	A. Other leadership and governance
139	teams;
140	B. Teacher learning communities; and
141	C. Other staff to manage the multiple
142	complex, joint work of school and community organizations.
143	(g) "Community School Director" means a person who:
144	(i) Is a full-time staff member serving one (1)
145	eligible school;
146	(ii) Is responsible for the identification,
147	implementation and coordination of integrated student supports,
148	expanded and enriched learning time and opportunities, family and
149	community engagement and collaborative leadership and practices;
150	(iii) Serves as a member of the school-based
151	leadership team;

152	(iv) Serves as the lead for the needs and assets
153	assessment and community school plan; and
154	(v) Coordinates the needs and assets assessment
155	and stakeholder-driven approach to problem-solving and continuous
156	improvement.
157	(2) The State Board of Education is authorized to approve
158	districts of innovation for the purposes of improving students'
159	educational performance. Districts of innovation shall be
160	provided flexibility from selected board regulations, Title 37,
161	Mississippi Code of 1972, and local school board policies for
162	school administrators, teachers and staff to meet the diverse
163	needs of students. A low-performing school or school district
164	managing the transition of multiple schools to the community
165	school model shall be provided a three-year transition before
166	becoming eligible for state takeover. The initial approval of a
167	district of innovation shall be for a five-year period. Each
168	renewal of a district of innovation shall not exceed five (5)
169	years and shall comply with administrative regulations promulgated
170	by the board pursuant to subsection (4) of this section.
171	(3) The board shall promulgate administrative rules and
172	regulations to prescribe the conditions and procedures to be used
173	by a local school board to be approved as a district of innovation
174	and shall publish the same on or before December 31, 2015.
175	(4) Administrative rules and regulations promulgated by the
176	board under subsection (3) of this section shall specify:

177	(a)	The	regulatory	areas	which	may	be	exempted	or

- 180 37-179-3(3);
- (b) The application, plan review, approval and
- 182 amendment process for a district;

- 186 (d) Acceptable documentation of a critical mass of
- 187 parental, community, educator and business support and capacity to
- 188 effect a change;
- 189 (e) Evidence of teacher collaboration and shared
- 190 leadership within the district and the schools to be designated as
- 191 schools of innovation;
- 192 (f) The process of revocation of the designation of
- 193 district of innovation or school of innovation;
- 194 (g) Reporting and oversight responsibilities of the
- 195 district and the State Department of Education;
- 196 (h) The financial detail relating to budgets of schools
- 197 and evidence of sound fiscal management practices;
- 198 (i) Acceptable areas of emphasis for innovation;
- 199 (j) Acceptable documentation of job-embedded
- 200 professional development within the proposed innovation design;

220	(* * $\star\underline{v}$) Increasing the participation of students
221	in various curriculum components and instructional components

337	(j) Allow community schools to seek and accept gifts,
338	grants, donations, and funds from federal and state agencies,
339	private foundations, organizations, or individuals for purposes
340	related to its function as a community school.
341	SECTION 4. This act shall take effect and be in force from
342	and after July 1, 2024.
