HOUSE BILL NO. 677

1       AN ACT TO AMEND SECTION 83-39-27, MISSISSIPPI CODE OF 1972,  
2 TO REVISE THE PROHIBITION ON A BAIL BONDSMAN GIVING LEGAL ADVICE  
3 OR LEGAL OPINION AND PROVIDE THAT SUCH ADVICE OR OPINION MUST RISE  
4 TO THE LEVEL OF PRACTICING LAW WITHOUT A LICENSE FOR IT TO BE  
5 CONSIDERED UNLAWFUL; AND FOR RELATED PURPOSES.

6       BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7       **SECTION 1.** Section 83-39-27, Mississippi Code of 1972, is  
8 amended as follows:

9       83-39-27. It is unlawful for a licensee to engage in any of  
10 the following activities:

11           (a) Specify, suggest or advise the employment of any  
12 particular attorney to represent his principal.

13           (b) Pay a fee or rebate or give or promise to give  
14 anything of value to a jailer, policeman, peace officer, clerk,  
15 deputy clerk, any other employee of any court, district attorney  
16 or any of his employees or any person who has power to arrest or  
17 to hold any person in custody.

18           (c) Pay a fee or rebate or give anything of value to an  
19 attorney in bail bond matters, except in defense of any act on a

20 bond, or as counsel to represent such bail agent, his agent or  
21 employees.

22 (d) Pay a fee or rebate or give or promise to give  
23 anything of value to the person on whose bond he is surety.

24 (e) Pay a fee or rebate or give or promise to give  
25 anything of value to any person, other than a soliciting bail  
26 agent, for the purpose of procuring a bail bond.

27 (f) Accept anything of value from a person on whose  
28 bond he is surety, or from others on behalf of such person, except  
29 the fee or premium on the bond, but the bail agent may accept  
30 collateral security or other indemnity.

31 (g) Coerce, suggest, aid and abet, offer promise of  
32 favor or threaten any person on whose bond he is surety or offers  
33 to become surety, to induce that person to commit any crime.

34 (h) Give legal advice or a legal opinion \* \* \* that  
35 would rise to the level of the licensee engaging in the practice  
36 of law without a license in violation of Section 73-3-55.

37 (i) Refuse to return collateral security or other  
38 indemnity when the fee or premium on the bond has been fully paid  
39 or when the bail agent's obligation on the bond has been  
40 terminated.

41 **SECTION 2.** This act shall take effect and be in force from  
42 and after July 1, 2025.
