HOUSE BILL NO. 889

1 AN ACT TO CREATE THE "MISSISSIPPI INDIGENT BURN CARE SUPPORT 2 FUND" AS A SPECIAL FUND IN THE STATE TREASURY; TO PROVIDE THAT 3 MONIES IN THE SPECIAL FUND MAY BE APPROPRIATED TO THE MISSISSIPPI DEPARTMENT OF HEALTH FOR THE PURPOSE OF CARRYING OUT CERTAIN 5 RESPONSIBILITIES ESTABLISHED IN SECTION 41-59-5 AND FOR 6 REIMBURSEMENT OF UNCOMPENSATED CARE TO MISSISSIPPIANS ADMINISTERED 7 BY OUT-OF-STATE BURN CENTERS THAT ARE AFFILIATED WITH LEVEL I 8 TRAUMA CENTERS IN THE MISSISSIPPI TRAUMA CARE SYSTEM; TO AMEND 9 SECTION 27-19-44.4, MISSISSIPPI CODE OF 1972, TO IMPOSE AN 10 ADDITIONAL FEE OF TWO DOLLARS FOR DISTINCTIVE OR SPECIAL LICENSE 11 TAGS AND TO PROVIDE THAT THE PROCEEDS COLLECTED FROM THE 12 ADDITIONAL FEE SHALL BE DEPOSITED INTO THE MISSISSIPPI INDIGENT 13 BURN CARE SUPPORT FUND CREATED IN THIS ACT; AND FOR RELATED 14 PURPOSES. 15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 16 SECTION 1. There is created in the State Treasury a special 17 fund to be known as the "Mississippi Indigent Burn Care Support Fund". The fund shall consist of monies deposited therein under 18 19 Section 27-19-44.4(3) and any other monies designated for deposit into the fund. The fund shall be maintained by the State 20 Treasurer as a separate and special fund, separate and apart from 21 22 the General Fund of the state. Unexpended amounts remaining in 23 the fund at the end of a fiscal year shall not lapse into the 24 State General Fund, and any interest earned or investment earnings H. B. - 25 on amounts in the fund shall be deposited into such fund. For
- 26 fiscal year 2025, and for each fiscal year thereafter, the
- 27 Legislature may appropriate monies in the Mississippi Indigent
- 28 Burn Care Support Fund. Any appropriation of funds from the
- 29 Mississippi Indigent Burn Care Support Fund shall be to the
- 30 Mississippi Department of Health for the purpose of carrying out
- 31 its responsibilities established in Section 41-59-5(7) and for
- 32 reimbursement of uncompensated care to Mississippians administered
- 33 by out-of-state burn centers that are affiliated with Level I
- 34 trauma centers in the Mississippi trauma care system. The
- 35 Mississippi Indigent Burn Care Support Fund shall be authorized to
- 36 accept gifts, donations, bequests, appropriations or other grants
- 37 from any source, governmental or private, for deposit into the
- 38 fund. The Department of Health shall be the agency responsible
- 39 for receiving any such gifts, donations, bequests, appropriations
- 40 or grants and shall deposit such to the Mississippi Indigent Burn
- 41 Care Support Fund.
- 42 **SECTION 2.** Section 27-19-44.4, Mississippi Code of 1972, is
- 43 amended as follows:
- 44 27-19-44.4. (1) Notwithstanding any other provision of law
- 45 to the contrary, beginning with any registration year commencing
- 46 on or after January 1, 2004, an additional fee of One Dollar
- 47 (\$1.00) is imposed for any distinctive or special license tag or
- 48 plate authorized under this chapter regardless of whether such a
- 49 distinctive or special license tag or plate was authorized before

- or after July 1, 2003. The proceeds collected from the additional
- 51 fee imposed under this section shall be deposited into the special
- 52 fund created under Section 27-19-56.69(8).
- 53 (2) Notwithstanding any other provision of law to the
- 54 contrary, beginning with any registration year commencing on or
- 55 after January 1, 2018, an additional fee of Two Dollars (\$2.00) is
- 56 imposed for any distinctive or special license tag or plate
- 57 authorized under this chapter regardless of whether such a
- 58 distinctive or special license tag or plate was authorized before
- or after July 1, 2018. The proceeds collected from the additional
- 60 fee imposed under this section shall be deposited into the
- 61 Mississippi Burn Care Fund created under Section 7-9-70.
- 62 (3) Notwithstanding any other provision of law to the
- 63 contrary, beginning with any registration year commencing on or
- 64 after July 1, 2025, an additional fee of Two Dollars (\$2.00) is
- 65 imposed for any distinctive or special license tag or plate
- 66 authorized under this chapter regardless of whether such a
- 67 distinctive or special license tag or plate was authorized before
- 68 or after July 1, 2025. The proceeds collected from the additional
- 69 fee imposed under this subsection shall be deposited into the
- 70 Mississippi Indigent Burn Care Support Fund created under Section
- 71 1 of this act.
- 72 (\star \star 4) The fees imposed under this section shall be in
- 73 addition to any other fees imposed under this chapter for a
- 74 distinctive or special license tag or plate.

- 75 (\star \star 5) The provisions of this section shall not apply to
- 76 distinctive or special license tags or plates:
- 77 (a) Which are issued under Section 27-19-46, 27-19-51,

- 82 (b) For which no additional fee is required to be paid.
