## HOUSE BILL NO. 1041

- AN ACT TO CREATE THE CRIME OF ABORTION TRAFFICKING; TO
  PROHIBIT ANY PERSON FROM TRANSPORTING A PREGNANT UNEMANCIPATED
  MINOR ACROSS STATE LINES FOR AN ABORTION WITH THE CONSENT OF THE
  MINOR'S PARENT OR GUARDIAN; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** (1) For purposes of this act, the following
- 7 definitions shall apply:
- 8 (a) "Abortion" means the use of any instrument,
- 9 medicine, drug or any other substance or device with intent to
- 10 terminate the pregnancy of a woman known to be pregnant, with
- 11 intent other than to increase the probability of a live birth, to
- 12 preserve the life or health of the child after live birth, or to
- 13 remove a dead fetus.
- 14 (b) "Emancipated minor" means any minor who is or has
- 15 by court order or otherwise been freed from the care, custody and
- 16 control of her parents or legal guardian;

- 22 (2) An adult who, with the intent to conceal an abortion
- 23 from the parents or guardian of a pregnant, unemancipated minor,
- 24 either procures an abortion, as described in, or obtains an
- 25 abortion inducing drug for the pregnant minor to use for an
- 26 abortion, by recruiting, harboring, or transporting the pregnant
- 27 minor within this state or outside this state commits the crime of
- 28 abortion trafficking. As used in this subsection, the terms
- 29 "procure" and "obtain" shall not include the providing of
- 30 information regarding a health benefit plan.
- 31 (3) It shall be an affirmative defense to a prosecution
- 32 under this act that a parent or quardian of the pregnant minor
- 33 consented to trafficking of the minor.
- 34 (4) It shall not be an affirmative defense to a prosecution
- 35 under this act that the abortion provider or the abortion inducing
- 36 drug provider is located in another state.
- 37 (5) The Mississippi Attorney General has the authority, in
- 38 his or her sole discretion, to prosecute a person for a criminal
- 39 violation of this act if the prosecuting attorney authorized to
- 40 prosecute criminal violations of this act refuses to prosecute
- 41 violations of any of the provisions of this act by any person
- 42 without regard to the facts or circumstances.
