HOUSE BILL NO. 1157

AN ACT TO AMEND SECTION 63-17-76, MISSISSIPPI CODE OF 1972,

TO REQUIRE USED MOTOR VEHICLE DEALERS RENEWING APPLICATION FOR THE

3 ISSUANCE OF A USED MOTOR VEHICLE DEALER'S LICENSE TO COMPLETE CONTINUING EDUCATION COURSE AS DETERMINED BY STANDARDS AGREED UPON 5 BY THE DEPARTMENT OF REVENUE AND THE MISSISSIPPI INDEPENDENT AUTO DEALERS ASSOCIATION; TO REMOVE THE EXEMPTION GRANTED TO USED MOTOR 7 VEHICLE DEALERS ENGAGED IN VEHICLE SALVAGE FROM CONTINUING 8 EDUCATION REQUIREMENTS AS A CONDITION OF DEALER LICENSURE; AND FOR 9 RELATED PURPOSES. 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 11 SECTION 1. Section 63-17-76, Mississippi Code of 1972, is 12 amended as follows: 63-17-76. (1) Every application for the issuance and 13 14 renewal of a used motor vehicle dealer's license shall be accompanied by such evidence as the * * * Department of Revenue 15 shall prescribe, documenting the completion of an education 16 17 seminar conducted by the Mississippi Independent Auto Dealers 18 Association during the twelve-month period immediately preceding the date of application. Completion of an eight-hour licensing 19 seminar conducted by the Mississippi Independent Auto Dealers 20

Association shall be required for an initial license.

- 22 Department of Revenue in conjunction with the Mississippi
- 23 Independent Auto Dealers Association shall determine the number
- 24 continuing education hours required for individuals renewing their
- 25 application for a used motor vehicle dealer's license. All
- 26 seminars must be approved by the * * * Department of Revenue. The
- 27 education requirements of this section shall not apply to:

- 29 (* * *a) A manufactured home dealer; or
- 30 (* * *b) A franchised new car dealer licensed under
- 31 the Mississippi Motor Vehicle Commission Law or any employee of
- 32 such a dealer.
- 33 (2) The Mississippi Independent Auto Dealers Association
- 34 shall submit to the * * * Department of Revenue a complete and
- 35 specific description of the seminars it conducts pursuant to this
- 36 section, a description of how the seminar will benefit licensees
- 37 in conducting their businesses, the number of hours involved, a
- 38 description of the method which will be used to ensure attendance,
- 39 and copies of any instructional materials which will be provided
- 40 to attendees. At the time approval is granted, the * * *
- 41 Department of Revenue shall determine how many hours of education
- 42 may be received by attending the program.
- 43 **SECTION 2.** This act shall take effect and be in force from
- 44 and after July 1, 2025.
