- 46 Administration Building" of the State Fire Academy that states the
- 47 background, accomplishments and service to the state of the former
- 48 Mississippi Insurance Commissioner and State Fire Marshal, George
- 49 Dale. The Department of Finance and Administration, in

- 50 conjunction with the Mississippi Department of Insurance, shall
- 51 erect or cause to be erected proper lettering or signage on the

- 89 Insurance, shall erect or cause to be erected proper lettering or
- 90 signage on the outdoor facade of the apparatus displaying the
- 91 official name of the building as the "Bill Warren Apparatus
- 92 Building." The Department of Finance and Administration may
- 93 expend all funds necessary to accomplish this act from funds
- 94 appropriated by the Legislature for such purpose.
