HOUSE BILL NO. 1331

- AN ACT TO AMEND SECTION 39-5-3, MISSISSIPPI CODE OF 1972, TO REVISE THE MEMBERSHIP OF THE DEPARTMENT OF ARCHIVES AND HISTORY BOARD OF TRUSTEES; AND FOR RELATED PURPOSES.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 39-5-3, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 39-5-3. The Department of Archives and History shall be
- 8 under the control of a board of nine (9) trustees. * * * From and
- 9 after July 1, 2025, the board shall be reconstituted to consist of
- 10 nine (9) trustees, eight (8) trustees from each of the four (4)
- 11 congressional districts, two (2) trustees from each district, as
- 12 such districts existed on July 1, 2025, and one (1) trustee to be
- 13 selected from the state at large, all of whom shall be appointed
- 14 by the Governor with the advice and consent of the Senate. The
- 15 initial appointments to the board shall be for staggered terms, to
- 16 be designated by the Governor at the time of appointment as
- 17 follows: two (2) trustees to serve for five (5) years, two (2)
- 18 trustees to serve for four (4) years, two (2) trustees to serve

- for three (3) years, two (2) trustees to serve for two (2) years,
- 20 and one (1) member, the at-large trustee, to serve for one (1)
- 21 year. When the board is reconstituted on July 1, 2025, all
- 22 trustees serving on the board on that date shall continue to serve
- 23 for a term of one (1) year. After the initial appointments, all
- 24 trustees chosen to succeed the present members or their successors
- 25 shall serve for a term of six (6) years. The board of trustees
- 26 shall hold at the State Capitol at least one (1) regular meeting
- 27 during the year, and as many special meetings as may be necessary,
- 28 and at \star \star those meetings five (5) members shall constitute a
- 29 quorum. The Director of the Department of Archives and History,
- 30 hereinafter provided, shall be secretary of the board. The
- 31 trustees shall receive no compensation for their services other
- 32 than the amount of their necessary expenses actually paid out
- 33 while in attendance on the meetings of the board or the business
- 34 of the department. The board is empowered to adopt rules for its
- 35 own government and for the government of the department, to elect
- 36 and fix the compensation of a director not to exceed the maximum
- 37 set by the Legislature, and other officials or employees, and to
- 38 do and perform such other acts and things as may be necessary to
- 39 carry out the true intent and purposes of this chapter.
- 40 **SECTION 2.** This act shall take effect and be in force from
- 41 and after July 1, 2025.
