## HOUSE BILL NO. 1347

- AN ACT TO CREATE THE MISSISSIPPI CHILD POVERTY TASK FORCE; TO PROVIDE FOR THE MEMBERSHIP OF THE TASK FORCE; TO PROVIDE THE 3 DUTIES OF THE TASK FORCE; AND FOR RELATED PURPOSES.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** (1) There is created the Mississippi Child
- 6 Poverty Task Force to review and make recommendations on how to
- 7 reduce overall child poverty in Mississippi and how to reduce the
- 8 number of Mississippi households that are asset limited, income
- 9 constrained, employed.
- 10 (2) The task force shall be composed of the following
- 11 members:
- 12 (a) Two (2) members of the Senate, to be appointed by
- 13 the Lieutenant Governor, with one (1) such member being a Democrat
- 14 and one (1) being a Republican;
- 15 (b) Two (2) members of the House of Representatives to
- 16 be appointed by the Speaker of the House of Representatives, with
- one (1) such member being a Democrat and one (1) being a

- The duties of the task force shall include the 28 (3)

- 30 Identifying and evaluating poverty's root causes (a)
- 31 and contributing factors in Mississippi, the needs of those in
- 32 poverty in Mississippi, and the effectiveness of efforts on all
- 33 levels that have been undertaken or are currently being undertaken
- 34 to address poverty; and developing strategies for supporting or
- 35 otherwise improving the efficacy of those efforts, including
- programmatic effectiveness and administrative efficiencies; 36
- 37 (b) Identifying and evaluating the nature and scope of
- 38 poverty's impact on various locations and communities throughout
- 39 Mississippi and what response actions would be most effective in
- 40 helping each of those impacted areas, and developing strategies
- 41 for implementing those response actions;
- 42 Identifying and evaluating what financial and other
- resources are available on all levels to combat poverty in 43

- 46 Identifying and evaluating key barriers to upward (d)
- 47 mobility among populations in poverty in Mississippi, and
- 48 developing strategies for overcoming these barriers, focusing on
- 49 improved economic development and opportunities for upward
- 50 mobility among families and individuals experiencing poverty in
- 51 Mississippi;
- 52 Developing strategies for increasing public
- 53 awareness of poverty in Mississippi, its causes and effects, the
- 54 resources available to those impacted by it, and the actions that
- 55 can be taken to combat it;
- 56 Developing routine communication and
- 57 information-sharing protocols between members of the task force
- and stakeholders on all levels; 58
- 59 Identifying key stakeholders in impacted areas and
- 60 performing outreach to ensure stakeholders are informed, educated,
- and empowered. Stakeholder outreach will include, but is not 61
- 62 limited to, community leaders, partner organizations, tribal
- 63 governments, local government officials, and other elected
- 64 officials representing the impacted areas;
- 65 Performing outreach to the general public regarding (h)
- 66 poverty in Mississippi and the work of the task force;
- 67 Creating measurable goals and objectives along an
- established timeline; 68

- 73 (k) Examining proposals to create, expand or strengthen
- 74 tax proposals that have an impact on children; and
- 75 (1) Meeting with Alluvial Collective officials to offer
- 76 strategies to acknowledge and address inequalities in policy
- 77 decision-making.
- 78 (4) (a) Appointments to the task force shall be made within
- 79 thirty (30) days after the effective date of this act. Within
- 80 fifteen (15) days thereafter on a day to be designated jointly by
- 81 the Speaker of the House of Representatives and the Lieutenant
- 82 Governor, the task force shall meet and organize by selecting from
- 83 its membership a chair and a vice chair. The vice chair shall
- 84 also serve as secretary and shall be responsible for keeping all
- 85 records of the task force. A majority of the members of the task
- 86 force shall constitute a quorum. In the selection of its officers
- 87 and the adoption of rules, resolutions and reports, an affirmative
- 88 vote of a majority of the task force shall be required. All
- 89 members shall be notified in writing of all meetings, and those
- 90 notices shall be mailed at least fifteen (15) days before the date
- 91 on which a meeting is to be held.

- 93 and provide quarterly reports to the Legislature on its
- 94 activities.
- 95 (c) The task force shall make a final report of its
- 96 findings and recommendations, including any recommended
- 97 legislation, to the Legislature not later than July 1, 2026, at
- 98 which time the task force will be dissolved.
- 99 (5) Members of the task force shall receive no compensation
- 100 for their service on the task force, but may receive reimbursement
- 101 for mileage and actual expenses as provided in Section 25-3-41,
- 102 Mississippi Code of 1972, to the extent that funds are available
- 103 for that purpose.
- 104 (6) The Mississippi Development Authority shall provide the
- 105 staff and other support necessary for the task force to perform
- 106 its duties.
- 107 (7) To effectuate the purposes of this act, any department,
- 108 division, board, bureau, committee, institution or agency of the
- 109 state, or any political subdivision thereof, shall, at the request
- 110 of the chairman of the task force, provide the facilities,
- 111 assistance, information and data needed to enable the task force
- 112 to carry out its duties.
- 113 **SECTION 2.** This act shall take effect and be in force from
- 114 and after its passage.
