HOUSE BILL NO. 1622

- AN ACT TO BRING FORWARD SECTION 37-161-3, MISSISSIPPI CODE OF 1972, WHICH CREATES THE MISSISSIPPI VIRTUAL PUBLIC SCHOOL PROGRAM, FOR THE PURPOSE OF POSSIBLE AMENDMENTS; AND FOR RELATED PURPOSES.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 37-161-3, Mississippi Code of 1972, is
- 6 brought forward as follows:
- 7 37-161-3. (1) The Legislature finds and declares the
- 8 following:
- 9 (a) Meeting the educational needs of children in our
- 10 state's schools is of the greatest importance to the future
- 11 welfare of the State of Mississippi;
- 12 (b) Closing the achievement gap between high-performing
- 13 students, including the achievement gap among at-risk students, is
- 14 a significant and present challenge;
- 15 (c) Providing a broader range of educational options to
- 16 parents and utilizing existing resources, along with technology,
- 17 may help students in the state improve their academic achievement;

- 22 (2) There is created the Mississippi Virtual Public School 23 Program, which is the responsibility of the State Department of 24 Education. It is the intent of the Legislature that the Mississippi Virtual Public School established under this section 25 26 provides Mississippi families with an alternative choice to access 27 additional educational resources in an effort to improve academic 28 achievement. The Mississippi Virtual Public School must be 29 recognized as a public school and provide equitable treatment and 30 resources as are other public schools in the state. Private 31 providers, overseen by the State Department of Education, may be 32 selected by the State Board of Education to administer, manage or operate virtual school programs in this state, including the total 33 34 operation of the Mississippi Virtual Public School Program. 35 private provider chosen to provide services under the provisions of this subsection shall be chosen through the Mississippi Online 36 37 Course Application Process.
- 38 (3) Nothing in this section may be interpreted as precluding 39 the use of computer- and Internet-based instruction for students 40 in a virtual or remote setting utilizing the Mississippi Virtual 41 Public School.

42 (4) As used in this section, the following words and phr

- 43 have the meanings respectively ascribed unless the context clearly
- 44 requires otherwise:
- 45 (a) "Mississippi Virtual Public School" means a public
- 46 school in which the state uses technology in order to deliver
- 47 instruction to students via the Internet in a virtual or remote
- 48 setting.
- 49 (b) "Sponsor" means the public school district is
- 50 responsible for the academic process for each student, including,
- 51 but not limited to, enrollment, awarding of credit and monitoring
- 52 progress.
- 53 (5) (a) The State Board of Education shall establish the
- 54 Mississippi Virtual Public School beginning in school year
- 55 2006-2007.
- 56 (b) Students who enroll in the Mississippi Virtual
- 57 Public School may reside anywhere in the State of Mississippi.
- 58 (6) Subject to appropriation, the Mississippi Virtual Public
- 59 School shall provide to each student enrolled in the school all
- 60 necessary instructional materials. Subject to appropriation, the
- 61 sponsored school must ensure that each student is provided access
- 62 to the necessary technology, such as a computer and printer, and
- 63 to an Internet connection for schoolwork purposes.
- 64 (7) The Mississippi Department of Education shall have
- 65 approval authority for all coursework and policy of the
- 66 Mississippi Virtual Public School.

67	(8) Each teacher employed by or participating in the
68	delivery of instruction through the Mississippi Virtual Public
69	School must meet all qualifications for licensure in the State of
70	Mississippi.

- 71 (9) Any student who meets state residency requirements may 72 enroll in the Mississippi Virtual Public School.
- 73 Enrollment in the Mississippi Virtual Public School 74 shall be free of charge to students. The costs associated with 75 the operations of the virtual school must be shared by the State 76 Department of Education, subject to appropriation, and/or the 77 local school districts. Once the State Department of Education 78 appropriation and the local school district budgeted funds for Mississippi Virtual Public School have been expended and students 79 80 choose to enroll in online courses, the costs of the online courses may be the responsibility of the students' parents or 81 82 quardians.
- 83 **SECTION 2.** This act shall take effect and be in force from 84 and after July 1, 2025.
